Volunteer Infantry casualties at Cold Harbor, June 1-12, 1864.
Collated with NYSAG Report and newspaper lists.**

ALLEN , RUFUS E.—Age, 21 years. Enlisted, August 6, 1862, at Stockholm, to serve three years; mustered in as corporal, Co. G, August 27, 1862; returned to ranks, no date; **killed in action, June 3, 1864, at Cold Harbor, Va.**

ANDREWS, EDWIN R—Age, 23 years. Enlisted, August 8, 1862, at Brasher, to serve three years; mustered in as corporal, Co. F , August 27, 1862; **killed in action,. June 1, 1864, at Cold Harbor, V a.**

ARMSTRONG, MARTIN A.C.—Age 38 years. Enlisted, August 16, 1862 at Malone, to serve three years; mustered in as private, Co. I, August 27, 1862; killed in action, April 2, 1865, at Petersburg, Va. [*head, slight*]

BACKUS, ERASTUS P.—Age 18 years. Enlisted August 13, 1862, at Russell, to serve three years; mustered in as private, Co. A, August 27, 1862; discharged for disability, March 18, 1865, at Washington, DC. [*Wounded after June 4 at Cold Harbor. Newspaper says severe arm wound*](*died January 2, 1918 at Russell, NY*)

BALINTINE , HUGH.—Age, 19 years. Enlisted, July 21, 1862, at Depeyster, to serve three years; mustered in as private, Co. C, August 27, 1862; promoted corporal, no date; mustered out with detachment, May 17, 1865, at Saterlee Hospital, West Philadelphia, Pa . ; prior service in Co. G, Sixteenth N. Y. Infantry. [*News: arm, side, leg, severe*](*died October 13, 1920 at Waverly, Iowa*)

BANISTER, AZRO I.—Age, 18 years. Enlisted, August 11, 1862, at Edwards, to serve three years; mustered in as private, Co. K, August 27. 1862; **killed ‘in action, June 1, 1864, at Cold Harbor, Va.** ; also borne as Bannaster.

BARNEY, ELIJAH H.—Age, 18 years. Enlisted, August 7,1862, at Canton, to serve three years; mustered in as musician, Co. A, August 27, 1862; grade changed to private, no date; mustered out with company, June 22, 1865, near Washington, D. C. [*Potsdam Courier and Freeman says neck wound, slight*] (*died March 7, 1915 at Brier Hill, NY*)

BAYNE , J A M E S H.—Age, 18 years. Enrolled, July- 19, 1862, at Morristown, to serve three years; mustered in as sergeant, Co. B, August 27, 1862; promoted first sergeant, March 18, 1863; mustered in as second lieutenant, October 2, 1863; **killed in action, June 1, 1864, at Cold Harbor, Va.**

Commissioned second lieutenant, September 14, 1863, with rank from August 28, 1863, vice R. Riddle, discharged.

BEEBE, ALBERT—Age 25 years. Enlisted, August 13, 1862, at DeKalb, to serve three years; mustered in as private, Co. C, August 27, 1862; promoted corporal, March 1, 1865; mustered out with company, June 22, 1865, near Washington, DC. [*Newspaper says severe hand wound*] (died September 22, 1902)

BELLINGER , ALLYN L.—Age, 18 years. Enlisted, July 23, 1862, at Morristown, to serve three years; mustered in as private, Co. B, August 27, 1862; mustered out with company, June 22, 1865, near Washington, D. C. [*Newspaper says , arm, slight*](died December 2, 1919 at Midland, Michigan)

BEST, WILLIAM K.—Age, 24 years. Enlisted, July 22, 1862, at Ogdensburg, to serve three years; mustered in as corporal, Co. D, August 27, 1862; promoted sergeant, no date; transferred to Co, A, Tenth Regiment, Veteran Reserve Corps, and returned to ranks, no dates; mustered out with detachment, June 28, 1865, at Washington, D. C. [*thigh, slight; was listed as sergeant at Cold Harbor*]

BILLINGS, JOHN W.—Age, 25 years. Enlisted, July 24, 1862, at Canton, to serve three years, mustered in as private, Co. K, August 27, 1862; promoted corporal and sergeant, no dates; killed in action, October 19, 1864, at Cedar Creek, Va. [*head, slight; listed as sergeant at Cold Harbor*]

BLACKMAN , AARON B.—Age, 27 years. Enrolled, July 21, 1862, at Madrid, to serve three years; mustered in as sergeant, Co. G, August 27, 1862; promoted first sergeant, January 1, 1863; mustered in as second lieutenant, March 2, 1864; **killed in action, June 1, 1864, at Cold Harbor, Va .** Commissioned second lieutenant, November 25, 1863, with rank from August 1, 1863, vice M. W. Leavings, promoted.

BROMELING, MARTIN.—Age, 25 years. Enlisted, August 16, 1862, at Oswegatchie, to serve three years; mustered in as private, Co. C, August 27, 1862; **killed in action, June 1, 1864, at Cold Harbor, Va.**

BROMELING, THOMAS.—Age, 23 years. Enlisted, August 16, 1862, at Oswegatchie, to serve three years; mustered in as private, Co. C, August 27, 1862; **wounded in action, no date; died of his wounds, August 11, 1864, at Frederick, Md.** [*Although not mentioned in the newspaper as wounded at Cold Harbor, this seems likely and Martin Bromeling is probably a brother...since both men died, it could lead to confusion on the part of the newspaper reporter.*]

BOOTH, DANIEL---Age 22 years. Enrolled, August 2, 1862, at Edwards, to serve three years; mustered in as corporal, Co. K, August 27, 1862; promoted sergeant, prior to April, 1863; first sergeant, no date; mustered in as first lieutenant, February 12, 1865; mustered out, July 3, 1865, at Ogdensburg, N.Y.

Commissioned first lieutenant, May 11, 1865, with rank from February 12, 1865, vice J.C. Birge, promoted. [*newspaper describes wound a thigh, severe*]

BROWN, ALONZO.---Age 29 years. Enlisted July 19, 1862, at Malone, to serve three years; mustered in as corporal, Co. I, August 27, 1862; promoted sergeant, March 1, 1862; returned to ranks, no date; discharged, October 17, 1864. [*leg, slight*]

BROWN, HARVEY.—Age, 29 years. Enlisted, August 11, 1862, at Edwards, to serve three years; mustered in as private, Co. K, August 27, 1862; **killed in action, June 1, 1864, at Cold Harbor, Va.** [*missing*]

BRUNSON, JESSIE H.—Age, 21 years. Enlisted, August 1, 1862, at Dickinson, to serve three years; mustered in as private, Co. H, August 27, 1862; promoted, corporal, no date; **wounded in action, June 1, 1864, at Cold Harbor, Va. ; died of his wounds, June 19, 1864, at Alexandria, Va.** [*head, severe*]

BUCKMAN , EDWARD A.—Age, 21 years. Enlisted, August 12, 1862, at Morristown, to serve three years; mustered in as corporal, Co. C, August 27, 1862; promoted sergeant, prior to April, 1863; first sergeant, no date; discharged for disability, May 15, 1865.

Commissioned, not mustered, first lieutenant, January 26, 1865, with rank from January 7, 1865, vice C. Snyder, promoted. [*News says, back, slight*]

CARR, HENRY.—Age, 28 years. Enlisted, July 25, 1862, at De Peyster, to serve three years; mustered in as private, Co. C, August 27, 1862; wounded and captured in action, June 1, 1864, at Cold Harbor, Va. ; paroled, no date; mustered out with company, June 22, 1865, near Washington, D. C. [*Newspaper says, bowels, severe*]

CHAMBERS, JOHN R.—Age, 18 years. Enlisted, July 25, 1862, at De Peyster, to serve three years; mustered in as private, Co. C, August 27, 1862; mustered out with company, June 22, 1865, near Washington, D. C. [*arm, severe*]

CHARTER, JR., STEPHEN.—Age, 21 years. Enlisted, July 29, 1862, at Macomb, to serve three years; mustered in as private, Co. C, August 27, 1862; wounded in action, June 1, 1864, at Cold Harbor, Va.; absent, wounded, at muster-out of company. [*Newspaper says, thigh, severe*]

CLARK, FREDERICK.—Age, 18 years. Enlisted, July 25, 1862, at De Peyster, to serve three years; mustered in as private, Co. C, August 27, 1862; promoted corporal, no date; **killed in action, June 1, 1864, at Cold Harbor, Va.** [*News reports him as missing*]

COBURN, AMASA—Age, 24 years. Enlisted, August 8, 1862, at Malone, to serve three years; mustered in as corporal, Co. H, August 27, 1862; captured in action, June 1, 1864, at Cold Harbor, Va. ; no further record. [Died at Andersonville, October 1, 1864 #10,129] [missing] (*Mother applies for pension on November 15, 1869*)

COLLAR, CHARLES.—Age, 22 years. Enlisted, July 26, 1862, at Morristown, to serve three years; mustered in as private, Co. B, August 27, 1862; died of disease, June 9, 1864, at Cold Harbor, Va.

COOK, BENJAMIN.—Age 33 years. Enlisted August 12, 1862, at Malone, to serve three years; mustered in as private, Co. I, August 27, 1862; promoted sergeant, no date; mustered out with company, June 22, 1865, near Washington, D.C. [*thigh, severe; listed as corporal at Cold Harbor*]

CONKLIN, J.—not found in NYSAG roster

COGHLIN, JOHN.—Age, 21 years. Enlisted, July 17, 1862, at Ogdensburg, to serve three years; mustered in as private, Co. I, August 27, 1862; discharged for disability, May 15, 1865; also borne as Coughlin. [*news lists him as Co. I member with severe hand wound*]

COPELAND, NELSON—Age 19 years. Enlisted at Rochester, to serve three years, and mustered in as private, Co. K, December 7, 1863; captured in action, July 9, 1864, at Monocacy, Md.; released, February 22, 1865, at North East Bridge, N.C.; mustered out, June 26, 1865, at Annapolis, Md. [*newspaper says he was missing at Cold Harbor; appears to have survived imprisonment at Salisbury prison, NC; a survivor who finally dies on March 1, 1920 at Cape Vincent, NY*]

CORBEN, MELZER M.—Age, 20 years. Enlisted, August 2, 1862, at Bucksbridge, to serve three years; mustered in as private, Co. G, August 27, 1862; promoted corporal, no date; first sergeant, February 10, 1865; mustered out with company, June 22, 1865, near Washington, D. C. [*arm wound*]

DENNIS, ALVIN A.—Age, 19 years. Enlisted, August 9, 1862, at Malone, to serve three years; mustered in as private, Co. H, August 27, 1862; captured in action, June 1, 1864, at Cold Harbor, Va.; died, September 28, 1864, at Andersonville, Ga. [missing]

DENIEN, JOHN.—Age, 18 years. Enlisted, December 17, 1863, at Madrid, to serve three years; mustered in as private, Co. G, January 4, 1864; discharged for disability, January 20, 1865. [*shoulder wound*]

DOROTHY, FRANKLIN B.—Age, 18 years. Enlisted, December 23, 1863, at Malone, to serve three years; mustered in as

private, Co. A, January 1, 1864; wounded in action, July 9, 1864, at Monocacy, Md.; mustered out, July 27, 1865, at hospital, Annapolis, Md. [*Newspaper says head, slight*]

DRAKE , ASHAEL C—Age, 21 years. Enlisted, August 11, 1862, at Parishville, to serve three years; mustered in as private, Co. E , August 27, 1862; wounded, no date; absent, at Davids Island, New York Harbor, at muster-out of company. [*Newspaper says wrist, severe*]

DURANT, JUSTUS.—Age, 25 years. Enlisted, August 11, 1862, at Louisville, to serve three years; mustered in as private, Co. F, August 27, 1862; **missing in action, June 1, 1864, at Cold Harbor, Va . ; no further record.** [Not found in NPS Andersonville POW database] [*newspaper says missing*](*Widow applies for pension on December 2, 1865*)

ELLS, PERRY.—Age, 31 years. Enlisted July 25, 1862, at Ogdensburg, to serve three years; mustered in as private, Co. I, August 27, 1862; **died of disease, August 20, 1864, while a prisoner of war, at Andersonville, Ga.** [*since newspaper describes his wound as shoulder, slight, it would appear that Ells was likely captured at Petersburg in mid-June. August 20, 1864 was the peak of the daily death toll at Andersonville. His widow and minor apply for a pension on July 22, 1865*]

EUSTIS, GEORGE D.—Age, 18 years. Enlisted, August 13, 1862, at Depeyster, to serve three years; mustered in as private, Co. C, August 27, 1862; mustered out with company, June 22, 1865, near Washington, D. C. [*Paper says, hand, severe*]

FARDEN , JAMES.—Age, 21 years. Enlisted, July 21, 1862, at Oswegatchie, to serve three years; mustered in as private, Co. C, August 27, 1862; promoted corporal, no date; mustered out with detachment, May 17, 1865, at Satterlee Hospital, West Philadelphia. Pa. [*News says, head, severe*]

FERRIS, WARREN J.—Age, 18 years. Enlisted, August 14, 1862, at Nicholasville, to serve three years; mustered in as private, Co. H , August 27, 1862; **killed in action, June 1, 1864, at Cold Harbor, Va . ;** also borne as Fennis.

FIELDSON, GEORGE.—Age, 23 years. Enlisted, July 25, 1862, at De Peyster, to serve three years; mustered in as sergeant, Co. C, August 27, 1862; wounded in action, June 1, 1864, at Cold Harbor, Va . ; returned to ranks, no date; transferred to Fifth Company, Second Battalion, Veteran Reserve Corps, September 3, 1864; mustered out with detachment, August 27, 1865, at Ward's Hospital, Newark, N. J . [*Hand, severe*]

FOLSOM, ALFRED.—Age, 18 years. Enlisted, August 1, 1862, at Stockholm, to serve three years; mustered in as private, Co. G, August 27, 1862; mustered out with company, June 22, 1865, near Washington, D. C.; also borne as Fulsom. [*arm wound*]

GERO, STEPHEN.—Age, 18 years. Enlisted, August 2, 1862, at Potsdam, to serve three years; mustered in as private, Co. E, August 15, 1862; wounded in action and died of his wounds, June 17, 1864, in hospital, at Washington, D. C. [*News says thigh, severe*]

GIBB, JAMES.—Age, 30 years. Enlisted, July 26, 1862, at Morristown, to serve three years; mustered in as private, Co. B, August 27, 1862; wounded in action, June 1, 1864, at Cold Harbor, Va.; sent to hospital; no further record. [*News says shoulder, severe*]

GLAZIER, LEVI.—Age, 21 years. Enlisted, August 12, 1862, at •Malone, to serve three years; mustered in as private, Co. H, August 27, 1862; killed in action, June 8, 1864, at Cold Harbor, Va.

HANNA, ADAMS.—Age, 23 years. Enlisted, July 28, 1862, at Lisbon, to serve three years; mustered in as private, Co. D, August 27, 1862; killed in action, June 5, 1864, at Cold Harbor, Va.

HARWOOD, EDWIN W.—Age, 20 years. Enlisted, August 12, 1862, at Malone, to serve three years; mustered in as corporal, Co. H, August 27, 1862; killed in action, June 8, 1864, at Cold Harbor, Va.

HEPBURN, HAWLEY S.—Age, 22 years. Enrolled, August 4, 1862, at Colton, to serve three years; mustered in as sergeant, Co. K, August 27, 1862; promoted first sergeant, prior to April, 1863; mustered in as second lieutenant, November 6, 1863; as captain, February 11, 1865; mustered out, July 3, 1865, at Ogdensburg, N. Y. [*Newspaper reports face, slight*]

Commissioned second lieutenant, November 25, 1863, with rank from November 5, 1863, vice H. Pickett, resigned; captain, March 14, 1865, with rank from February 11, 1865, vice 5. C. Judson, discharged.[]

HITCHCOCK, ANDREW J.—Age, 21 years. Enlisted, August 1, 1862, at De Kalb, to serve three years; mustered in as corporal, Co. C, August 27, 1862; killed in action, June 1, 1864, at Cold Harbor, Va.

HOWARD, MYRON E.—Age, 20 years. Enlisted, August 12, 1862, at South Canton, to serve three years; mustered in as

corporal, Co. E , August 27, 1862; wounded in action, June 7, 1864, at Cold Harbor, Va. ; returned to ranks, March 1, 1865; mustered out, June 5, 1865, at Washington, D. C. [*leg, severe*]

HULL , CHARLES.—Age, 21 years. Enlisted, August 9, 1862, at Potsdam, to serve three years; mustered in as private, Co. E , August 27, 1862; mustered out with company, June 22, 1865, near Washington, D. C. [*newspaper lists him as missing*]

HUNTINGDON, CHARLES H.—Age, 18 years. Enlisted August 9, 1862, at Malone, to serve three years; mustered in as private, Co. I, August 27, 1862; promoted corporal, December 1, 1864; mustered out with company, June 22, 1865, near Washington D.C. [*neck, severe*]

HUNTLEY , OSCAR F.—Age, 28 years. Enlisted, August 9, 1862, at Malone, to serve three years; mustered in as private, Co. I, August 27, 1862; wounded in action, June 1, 1864, at Cold Harbor, Va. ; died of his wounds, June 19, 1864, at Alexandria, Va. [*groin, severe*]

HUNTLY , A. P.—Age, 41 years. Enlisted, August 9, 1862, at Stockholm, to serve three years; mustered in as private, Co. G, August 27, 1862; wounded in action, June 2, 1864, at Cold Harbor, Va. ; mustered out with detachment, May 22, 1865, from Mower Hospital, Philadelphia, P a . ; also borne as Amos P. Hartley.

HUTCHINSON, ORVILLE.—Age, 20 years. Enlisted, August 27, 1862, at Ogdensburg, to serve three years; mustered in as private, Co. F, February 18, 1863; captured in action and paroled, April 29, 1863, at Fairmont, Va . ; discharged for disability, March 6, 1865. [*news says leg*]

INNMAN, ADDISON.—Age, 23 years. Enlisted, August 16, 1862, at Potsdam, to serve three years; mustered in as private, Co. E , August 27, 1862; wounded in .action, June 1, 1864, at Cold Harbor, Va. ; absent, in hospital at Rochester, N. Y., at muster-out of company. [*shoulder, severe*][Applies for pension as an invalid in October 1865; appears to have died before June 1870]

ISAACS, WILLIAM.—Age, 18 years. Enlisted, July 28, 1862, at Ogdensburg, to serve three years; mustered in as private, Co. I, August 27, 1862; mustered out with company, June 22, 1865, near Washington, D. C. [*leg, slight*]

IVES, EDWARD .—Age, 19 years. Enlisted, August 13, 1862, at Edwards, to serve three years; mustered in as private,

Co. K , August 27, 1862; **killed in action, June 1, 1864, at Cold Harbor, Va.** [*breast, mortally*]

JOHNSON, HENRY J.—Age, 23 years. Enlisted, August 13, 1862, at Malone, to serve three years; mustered in as private, Co. H, August 27, 1862; promoted corporal, no date; mustered out with company, June 22, 1865, near Washington, D. C. [*face, severe*]

KECH , WILLIAM.—Age, 19 years. Enlisted, August 5, 1862, at De Peyster, to serve three years; mustered in as private, Co. C, August 27, 1862; discharged for disability, August 27, 1864. [*Newspaper says, arm, severe*]

KELLY , PATRICK J.—Age, 25 years. Enlisted, August 11, 1862, at Morristown, to serve three years; mustered in as private, Co. B, August 27, 1862; promoted corporal, no date; **died of disease, September 23, 1864, while a prisoner of war, at Andersonville, Ga.;** also borne as Kelley. [*News says missing between June 1-4*]

KERRY , JOHN.—Age, 31 years. Enlisted, August 9, 1862, at Malone, to serve three years; mustered in as private, Co. I, August 27, 1862; captured in action, June 1, 1864, at Cold Harbor, Va . ; paroled, April 29, 1865; mustered out, July 12, 1865, at Albany, N. Y. [*not in newspaper list; NPS Andersonville database says he was Exchanged on April 15, 1865*]

LADUKE , MOSES.—Age, 21 years. Enlisted, July 26, 1862, at Malone, to serve three years; mustered in as private, Co. I, August 27, 1862; **wounded in action, June 1, 1864, and died of his wounds, June 2, 1864, at Cold Harbor, Va .** [*groin, severe*]

LAFORGE, ABIEL T.—Age, 23 years. Enrolled at Cold Harbor, Va. , to serve three years, and mustered in as first lieutenant, Co. F , June 9, 1864; as captain, Co. I, February 4, 1865; mustered out with company, June 22, 1865, near Washington, D. C. Commissioned first lieutenant, May 18, 1861, with rank from April 11, 1864, vice M. W . Leavings, resigned; captain, January 26, 1865, with rank from October 1, 1861, vice S. Parker, deceased. [NOT a casualty at Cold Harbor]

LANG , CHARLES H.—Age, 26 years. Enlisted, July 18, 1862, at Malone, to serve three years; mustered in as sergeant, Co. I, August 27, 1862; promoted first sergeant, February 28, 1863; sergeant-major, March 10, 1863; captured in action, June 1, 1864, at Cold Harbor, Va . ; returned to ranks, March 1, 1865; paroled, April 12, 1865; promoted corporal, May 1, 1865; sergeant-major, no date; discharged, August 2, 1865, at New York city. [Not found in NPS database] [*missing*]
Commissioned, not mustered, second lieutenant, March 14,

1865, with rank from February 11, 1865, vice H . S. Hepburn, promoted.

LEARY, JOHN.—Age, 30 years. Enlisted July 17, 1862, at Ogdensburg, to serve three years; mustered in as private, Co.I, August 27, 1862; promoted corporal March 10, 1863; wounded in action, October 19, 1864 at Cedar Creek, Va. No further record; also borne as Larry. [*received back wound at Cold Harbor*](*appears to have died around June 1865*)

LEONARD, JR., WILLIAM.—Age, 21 years. Enlisted, August II, 1862, at Pierpont, to serve three years; mustered in as private, Co. K , August 27, 1862; wounded in action, June 1, 1864, at Cold Harbor, Va. ; transferred to Co. I, Eleventh Regiment, Veteran Reserve Corps; mustered out with detachment, July 7, 1865, at Plattsburg, N. Y . [*newspaper says arm wound*]

LITTLEJOHN, SILAS.—Age, 30 years. Enlisted August 9, 1862, at Colton, to serve three years, and mustered in as private, Co. K, August 27, 1862; promoted sergeant, no date; mustered out with company, June 22, 1865, near Washington, D.C. [*newspaper says he was a corporal and got shoulder wound, severe*]

LISKUN , HARRISON.—Age, 20 years. Enlisted, August 14, 1862, at De Kalb, to serve three years; mustered in as private, Co. C, August 27, 1862; mustered out with company, June 22, 1865, near Washington, D. C. [*Paper says, foot, severe*]

MACK, WILLIAM O.—Age, 27 years. Enlisted, August 11, 1862, at Potsdam, to serve three years; mustered in as private, Co. E , August 27, 1862; died, November 28, 1864, while a prisoner of war, at Danville, Va. [*Newspaper says head, slight; probably captured at Moncacy, MD since many captured there were sent to Danville prison; there is a seemingly pretty comprehensive listing of deaths at Danville in the 1866 Record of the Federal Dead published U.S. Christian Commission which gives Mack's death date as October 23. His father applied for a pension on June 3, 1879*]

McALLISTER, WILLIAM H.—Age 18 years. Enlisted August 8, 1862, at Oswegatchie, to serve three years; mustered in as private, Co. A, August 27, 1862; discharged for disability August 2, 1863, at Point Lookout, Md.; also borne as McAllester. [*Wounded after June 4, at Cold Harbor. Newspaper says severe face wound. Possible that disability discharge date is an entire year off and actual date would be August 2, 1864. Otherwise, the record implies that this man reenlisted and was never properly put back on company roster. The former case is more likely.*]

McARTHUR, ORIN.—Age, 25 years. Enlisted, August 9, 1862, at Parishville, to serve three years; mustered in as private, Co. E, August 27, 1862; wounded in action, no date; died of his wounds, June 9, 1864, at Whitehouse Landing, Va. [*arm and leg, severe, probably on June 1 at Cold Harbor as the majority here*]

McBROOM, H. [not found in NYSAG report; the only McBroom is JOHN D.—Age, 28 years. Enrolled at Ogdensburg, to serve three years, and mustered in as first lieutenant, Co. K, August 27, 1862; as captain January 29, 1863; discharged January 13, 1865.

Commissioned first lieutenant, September 10, 1862, with rank from August 16, 1862, original; captain, February 24, 1863, with rank from January 29, 1863, vice Alexander Bingham, resigned. [*newspaper says slight arm wound*]

McDONALD, ANDREW A.—Age, 25 years. Enrolled at Ogdensburg, to serve three years, and mustered in as captain, Co. PECK, S—there were four Peck men in Company I. Stephen Peck is listed as having deserted subsequent to April 30, 1863. All were enlisted at Ogdensburg. Jason and Nelson were 44 years old at enlistment; Stephen was 39; Richard was 25. Only Richard served to June 1865. Jason went to the VRC in January 1865, Nelson was discharged in January 1865. The individual on the newspaper list had received a slight head wound.

Many Northern soldiers released from Salisbury at that time also died at Wilmington, NC. The usual references for those released from Salisbury are “exchanged at North East Bridge, NC.” Andersonville prisoners, once exchanged, are dead at Annapolis more commonly. Danville prisoners, less so. By educated guess, it would seem Private Kent went to Andersonville, which would imply capture at Cold Harbor...Here the fog of war rules since it would seem impossible to clarify the matter. Company records are very hazy around the time of Cold Harbor since many officers responsible had been casualties themselves and record-keeping devolved to less capable NCOs...]*

JARVIS , FRANCIS.—Age, 21 years. Enlisted, July 28, 1862, • at Malone, to serve three years; mustered in as private, Co. I, August 27, 1862; wounded, no date; mustered out, May 17, 1865, at Albany, N. Y.

McBRIDE, ELDRED.—Age, 33 years. Enlisted, July 31, 1862, at Malone, to serve three years; mustered in as private, Co. H , August 27, 1862; wounded, no date; died of his wounds, September 5, 1864, at City Point, Va. [*In general, soldiers killed at Cold Harbor and their bodies recovered, are buried in Robert E. Lee’s backyard at Arlington National Cemetery. This man is probably not a Cold Harbor casualty although the lingering period between wounds and death from them chimes well with this paper.*]

MERRIT, JOHN B.—Age, 20 years. Enlisted at New York city, to serve one year, and mustered in as private, Co. E , October 13, 1864; wounded in action, no date; discharged for wounds, April 29, 1865, at Judiciary Square Hospital, Washington, D. C. [*Many Cold Harbor wounded went to this hospital. There is a sentence in Ernest Ferguson’s*

book, Not War But Murder, that says, "The smell from embalming shops there was so depressing that capital newspapers complained that the undertakers were spreading pestilence and ruining the business of restaurants." Due to an OCR error, I have determined that Merrit was not wounded at Cold Harbor. However, I will use my error to make this point: Cold Harbor sacrificed so many officers and men that a cover-up occurred afterwards. Newspaper reporter Swinton had nailed it when he wrote, "...its valor quenched in blood, and thousands of its ablest officers killed and wounded, was the Army of the Potomac no more." The North ultimately used its power, money, numbers, and material to prevail; to get A. Lincoln re-elected, but, as this picture of the suffering of the 106th NY shows, the best and bravest of Adirondack, NY, were given to god Mars at Cold Harbor. And more at Monocacy and more at Petersburg, April 2nd, 1865. All for the Union.] Thus it is that war is too important to be left to the generals and politicians and corporations.
