K, October 7, 1862; promoted sergeant, no date; returned to ranks, January 2, 1863; again promoted sergeant prior to April 10, 1863; first sergeant prior to August, 1864; captured in action, August 25, 1864; paroled, October, 1864; promoted, sergeant-major, January 1, 1865; mustered in as first lieutenant, Co. A, to date December 28, 1864; mustered out with company, July 15, 1865, at Washington, D. C.; also borne as Doherty. [*Applies for pension as an invalid in April 1876---not granted*]

B, October 7, 1862; promoted sergeant, prior to April 10, 1863; mustered in as **first lieutenant**, Co. H, July 4, 1864; captured in action, August 25, 1864, at Ream's Station, Va.; paroled in February, 1865, and returned to company, April 12, 1865, mustered out with company, July 15, 1865, near Washington, D.C.; also borne as Freeland. McLAUGHLIN, OWEN.—Age, 31 years. Enlisted, September 18, 1862, at New York city, to serve three years; mustered in as private, Co. F, October 7, 1862; **wounded in action, May 24, 1864, at North Anna River, Va. ; also August 25, 1864, at Ream's Station, Va. ; absent since and in hospital at muster out of company;** also borne as McGlaughlin. [*Widow and minor applications in December 14, 1864*]

McMANUS, OWEN.—Age, 43 years. Enlisted, September 10, 1862, at New York city, to serve three years; mustered in as private, Co. F, October 7, 1862; **wounded in action, August 25, 1864, at Ream's Station, Va. ; discharged for disability from wounds, February 15, 1865.** [*Applies as an invalid in February 1865*]

MONTGOMERY, THOMAS.—Age, 29 years. Enrolled, September 3, 1862, at New York city, to serve three years; mustered in as private, Co. D, October 7, 1862; promoted, first sergeant, no date; mustered in as second lieutenant, February 1, 1863; as **first lieutenant, Co. A, March 22, 1864; wounded in action, August 25, 1864, at Ream's Station, Va. ; discharged for disability from wounds, October 1, 1864.** [*Died in 1905*] Commissioned second lieutenant, February 14, 1863, with rank from February 1, 1863, vice Joseph F. Donnelly promoted; first lieutenant, March 15, 1864, with rank from December 7, 1863, vice W. J. Burke resigned.

O'BRIEN, DANIEL.—Age, 27 years. Enlisted, September 13, 1862, at New York city, to serve three years; mustered in as private, Co. I, October 7, 1862; captured in action, June 16, 1864, at Petersburg, Va.; **died, October 28, 1864, at Salisbury, N. C.** [*Very few men captured at Petersburg; how this man got to Salisbury instead of Andersonville would be interesting to know*] [NOT found in Brown] [*NPAF*]

O'BRIEN, JOHN, 2nd.—Age, 37 years. Enlisted, August 29, 1862, at New York city, to serve three years; mustered in as private, Co. A, October 7, 1862; captured in action, August 25, 1864, at Ream's Station, Va. ; **died of diarrhea, October 29, 1864, at Salisbury, N. C.,** as John M. [*two John O'Brien's in Co. A; Widow applies on February 17, 1865 but this may also be John O'Brien below*] [NOT found in Brown]

O'BRIEN, JOHN.—Age, 23 years. Enlisted, September 13, 1862, at New York city, to serve three years; mustered in as private, Co. K, October 7, 1862; captured in action, August 25, 1864, at Ream's Station, Va. ; paroled, no date; mustered out, June 27, 1865, at Elmira, N. Y. [*Applies as invalid on June 3, 1882; no death date given*]

O'BRIEN, JOHN.—Age, 44 years. Enlisted, August 8, 1862, at New York city, to serve three years; mustered in as private, Co. A, October 7, 1862; captured in action, August 25, 1864, at Ream's Station, Va.; paroled, no date; **died of diarrhea, October 14, 1864; at Annapolis, Md.,** as John M. [*see above; in general I have observed that those who died after release from Confederate captivity at Camp Parole, Annapolis, MD, were lost in the gov't. woodworks for awhile and relatives were late in applying for pensions.*] [NOT found in Brown]

O'BRIEN, MARTIN.—Age, date of enlistment, place and mustered in as private, Co. A, not stated; captured in action, no date; **died of pneumonia, December 2, 1864, at Salisbury, N. C.** [*NPAF*] [In Brown as O'Brian, Martin, Pvt., A, 170th NY, 12-2-64]

O'SHANESSY, JOHN.—Age, 23 years. Enlisted, September 17, 1862, at New York city, to serve three years; mustered in as private, Co. F, October 7, 1862, and promoted corporal; captured in action, August 25, 1864, at Ream's Station, Va. paroled and returned to ranks, no date; mustered out, June 14, 1865, at hospital, Annapolis, Md., as O'Shaurressy. [*Applied as invalid on October 4, 1890; died August 24, 1902*]

OWENS, PATRICK.—Age, 35 years. ' Enlisted, August 27, 1862, at New York city, to serve three years; mustered in as private, Co. E, October 7, 1862; **wounded in action, August 25, 1864,** at Ream's Station, Va. ; **absent, since and at muster-out of company.** [*NPAF*]

PIGOTT, MORRIS.—Age, 33 years. Enlisted, September 4, 1862, at New York city, to serve three years; mustered in as private, Co. K, October 7, 1862; captured in action, August 25, 1864, at Ream's Station, Va. ; **died, October, 1864, at Salisbury, N. C.**; also borne as Maurice Piggott. [*Application for minor pension filed on December 1, 1865*] [NOT found in Brown]

PLUNKETT, AUSTIN O.—Age, 21 years. Enlisted, September 10, 1862, at New York city, to serve three years; mustered in as private, Co. F, October 7, 1862; promoted sergeant to date, September 10, 1862; **sergeant-major, June 10, 1864; wounded, August 25, 1864,** at Ream's Station, V a . ; retransferred as private, to Co. F, November 20, 1864; absent in quartermaster's department at City Point, Va., since November 21, 1864; discharged as sergeant-major, July 28, 1865, at New York city. [*Died February 3, 1932*]

QUIN, JAMES.—Age, 45 years. Enlisted, August 25, 1862, at New York city, to serve three years; mustered in as private, Co. A, October 7, 1862; promoted corporal prior to April 30, 1863; sergeant, April 30, 1861; **wounded in action, August 25, 1861,** at Ream's Station, V a . ; **died of his wounds, November 4, 1864;** also borne as Quinn.[*NPAF*]

REGAN, THOMAS.—Age, 31 years. Enlisted, August 25, 1862, at New York city, to serve three years; mustered in as private, Co. K, October 7, 1862; promoted corporal prior to October 31, 1863, and sergeant, August 31, 1864; captured in action, August 25, 1864, at Ream's Station, Va.; **died of diarrhea, November 23, 1864, at Salisbury, N. C.** [*Widow applies on March 25, 1865*] [IN Brown as Regan, Thomas, Pvt., K, 170th NY, 11-24-64]

RILEY, JOHN H.—Age, 24 years. Enlisted, August 12, 1862, at New York city, to serve three years; mustered in as private, Co. A , October 7, 1862; promoted sergeant prior to April, 1863; returned to corporal, August, 1863; **wounded and captured in action, August 25, 1864, at Ream's Station, Va. ; paroled, September 26, 1864;** promoted sergeant, February 1, 1865; first sergeant, June 1, 1865; mustered out with company, July 15, 1865, near Washington, D. C; also borne as Rielly. [*Died August 12, 1923 at Aurora, IL*]

SCHENCK, ALBERT.—Age, 21 years. Enlisted, September 11, 1862, at New York city, to serve three years; mustered in as private, Co. K, October 7, 1862; **wounded in action, August 25, 1864,** at Ream's Station, Va. ; **deserted, November 30, 1864,** at Lincoln Hospital, Washington, D.C. [*Widow possibly got a pension in 1887 under name of Ludwig A.Schenck*]

SHEEHAN , JOHN.—Age, 22 years. Enlisted, September 9, 1862, at New York city, to serve three years; mustered in as private, Co. E, October 7, 1862; promoted corporal, prior to April 10, 1863; captured in action, August 25, 1864, at Ream's Station, Va.; paroled, no date; mustered out, June 26, 1865, at Munson's Hill, Va. [*NPAF*]

SHEEHAN, JOHN.—Age, 43 years. Enlisted, September 11, 1862, at New York city, to serve three years; mustered in as private, Co. F, October 7, 1862; captured in action, August 25, 1864, at Ream's Station, Va.; **died, September 20, 1864, at Andersonville, Ga.** [*Probably Andersonville is incorrect. If not, this man was One of two unfortunates to go to Andersonville, both from Co. F. Their death dates there are the same. Andersonville was being emptied out of all but the very sick by early September, 1864.*] [IN Brown as Sheen, John, Pvt., F, 170th NY, 11-13-64]

SMITH, CHARLES G.—Age, 18 years. Enlisted, August 20, 1862, at Brooklyn, to serve three years; mustered in as private, Co. B, October 7, 1862; promoted corporal, July 1, 1864; captured in action, August 25, 1864, at Ream's Station, Va.; paroled, no date; mustered out, June 20, 1865, at Tilton Hospital, Wilmington, Delaware. [*Applies as invalid on January 16, 1907; the oldest survivor of captivity dies on March 18, 1932*] [IN Brown as Smith, Chas. W., Pvt., B, 170th NY, 1-17-65]

THOMAS, CHARLES H.—Age, 18 years. Enlisted, August 20, 1862, at Brooklyn, to serve three years; mustered in as private, Co. B, October 7, 1862; promoted corporal, prior to April 10, 1863; returned to ranks and promoted sergeant, no dates; missing in action, August 25, 1864, at Ream's Station, Va.; **died of intermittent fever, December 7, 1864, at Salisbury, N. C.** [*Father applies for pension on July 17, 1890*] [IN Brown as Thomas, Charles, Pvt., B, 170th NY, 12-7-64]

TURNER, GEORGE L . — Age, 25 years. Enrolled, July 28, 1862, at New York city, to serve three years; mustered in as first lieutenant, Co. C , October 7, 1862 ; as **captain, Co. B**, February 1, 1863; captured in action, August 25, 1864, at Ream's Station, Va.; **died, October 24, 1864, at Salisbury Prison, N.C.** as George S. Commissioned first lieutenant, November 10, 1862, with rank From September 13, 1862, original; captain, June 13, 1863, with rank from February 16, 1863, vice W . J . Holmes not mustered. [*53 pages of widow's pension file at www.fold3.com Some documents state he died at Columbia, SC and Danville, NC. Salisbury seems to have been the place settled upon. I think this is unlikely since the Confederates were very eager and ready to separate the officers from the enlisted men lest the former lead a revolt. B, October 7, 1862; captured in action, August 25, 1864, at Ream's Station, Va.; **died of disease, January 16, 1865, at Salisbury, N. C.** ; also borne as Am. [*Correct name is Von Arx; Mother applies on April 7, 1866*] [IN Brown as Vonart, Rodolph, Pvt., B, 170th NY, 1-16-65]

WALSH, PATRICK. — Age, 24 years . Enlisted, September 12, 1862, at New York city, to serve three years; mustered in as private, Co. G , October 7, 1862; promoted corporal , August, 1863; returned to ranks, July 1, 1864; promoted sergeant, prior to August, 1864; captured in action, August 25, 1864, at Ream' s Station, Va. ; paroled, no date; mustered out as private, May 29, 1865, at Rulison Hospital , Annapolis Junction, Md. also borne as Welsh. [*Appears to have died around January 1874*]

WARD, JOHN.---Age, 40 years. Enlisted, September 10, 1862, at New York city, to serve three years; mustered in as private, Co. D, October 7, 1862; missing in action, since August 25, 1864, at Ream's Station, Va.; absent since and at muster out of company; also borne as James John. [*1st Lt. Patrick Dunne swears affidavit on 13 November 1867 saying he saw a letter from a Confederate surgeon claiming John Ward died at Columbia, SC, on or about December 26, 1864, see widow's pension application at www.fold3.com*]

WOODS, HENRY,—Age, 21 years Enlisted, September 10, 1862, at New York city, to serve three years; mustered in as private, Co. D, October 7, 1862; captured in action, August 25, 1864, at Ream's Station, Va.; **died, November 15, 1864, at Salisbury, N. C.** [NPAF] [IN Brown as Wood, Henry, Pvt., D, 170th NY, 11-16-64]

YOUNG, JAMES.—Age, 21 years. Enlisted, August 15, 1862, at New York city, to serve three years; mustered in as private, Co. A, October 7, 1862; promoted corporal prior to April 10, 1863; sergeant, prior to April 30, 1864; **wounded** and captured in action, August 25, 1864, at Ream's Station, Va.; paroled, no date; discharged for disability, May 27, 1865, at Chester Hospital, Chester, Pa. [*Applies as invalid on December 1, 1865; died January 4, 1922 at West Allis, Wisconsin*]

2 officers and 14 enlisted men were killed in action or died of wounds... One was Major Donnelly.

1 officer and 5 enlisted men were wounded and recovered...

3 officers and 60 enlisted men were tallied as missing in action. My count for these casualties agrees nearly exactly with Phisterer's numbers. However, I think there are probably clerical errors, such as those supposedly captured at Ream's Station but sent to Andersonville, which seems quite unlikely. There is always a margin of error in these matters. However, this study seems highly accurate. Casualties are spread fairly evenly between all companies which would seem to say there's no evidence of a widespread collapse in the 170th. However, In an OR report, Colonel James Willett mentions that by October 26, the regiment

was “63 strong” going towards battle on that day. This suggests that at Ream’s the regiment was probably under 200 men, if that many. Colonel Murphy refers to them as a “small” regiment, along with the 155th NY who lost 6 officers and 32 enlisted men missing that day.

Some men seem to have been exchanged in September and October. At the same time 9 men died at Salisbury in October and that was the highest monthly total of deaths. It seems safe to say that the 170th NY was probably a pretty worn set of soldiers to go to Salisbury. As Ream’s Station captives, they would experience the most extreme overcrowded conditions and have to spend the greatest amount of time there under conditions of exposure to the elements without shelter and well-documented starvation before exchange back to Union lines in Late February and early March, 1865. Another factor may have been the ages of those captured---about 21 men over the age of 32 died compared with 9 under that age. Of survivors, I count 11 of them between ages 23 and 27 (out of around 22 men).

Most of the wounded seem to have been left behind by the rebels. By my count, over 55% of the captured died at Salisbury (or as a result of imprisonment there). What’s most shocking here is that so many died in September and October---a mere two months or less into captivity!
