**ANDERSON, JR., HIRAM** — Age, 34 years. Enrolled, October 10, 1861, at Potsdam, to serve three years; mustered in as captain/Co. A, October 30, 1861; as lieutenant-colonel, March 11, 1862; killed in action, June 1, 1864, at Cold Harbor, Va. Commissioned captain, January 13, 1862, with rank from October 10, 1861, original; lieutenant-colonel, April 14, 1862, with rank from March 13, 1862, vice L. F. Bingham resigned.

**COOPER, COURTLAND G.**—Age, 18 years. Enlisted at Potsdam, to serve three years, and mustered in as private, Co. I, October 28, 1861; re-enlisted as a veteran, December 14, 1863; killed in action, June 1, 1864, at Cold Harbor, Va .

**DANIELS, JAMES A.**—Age, 18 years. Enlisted at Edwards, to serve three years, and mustered in as private, Co. B, October 14, 1862; killed in action, June 1, 1864, at Cold Harbor, Va.

**DREWERY, JOHN.**—Age, 21 years. Enlisted at Potsdam, to serve three years, and mustered in as private, Co. G, January 7, 1863; killed in action, June 1, 1864, at Cold Harbor, Va.

**DUNCAN, JAMES E.**—Age, 18 years. Enlisted, October 10, 1861, at Potsdam, to serve three years; mustered in as private, Co. E, October 30, 1861; transferred to Co. D, June 11, 1863; killed in action, June 1, 1864, at Cold Harbor, Va.

**GLANN, HAMILTON.**—Age, 28 years. Enlisted at Massena, to serve three years, and mustered in as private, Co. K, October 27, 1862; transferred to Co. G, June 11, 1863; killed in action, June 1, 1864, at Cold Harbor, Va . ; also borne as Glan and Glen.

**GRAVES, PETER.**—Age, 39 years. Enlisted, October 10, 1861, at Potsdam, to serve three years; mustered in as private, Co. G, October 30, 1861; killed in action, June 1, 1864, at Cold Harbor, Va .

**LYON, HORACE H.**—Age, 19 years. Enlisted, October 10, 1861, at Potsdam, to serve three years; mustered in as private, Co. A, October 30, 1861; discharged, no date; again enlisted as private, Co. A, September 16, 1862; killed in action, June 3, 1864, at Cold Harbor, Va.

**MERRITT, WILLIAM.**—Age, 33 years. Enlisted at Hopkinton, to serve three years, and mustered in as private, Co. D, September 3, 1862; killed in action, June 1, 1864, at Cold Harbor, Va .

**MOFFITT, JAMES.**—Age, 42 years. Enlisted, November 4, 1861, at Potsdam, to serve three years; mustered in as private, Co. K, November 8, 1861; transferred to Co. G, June 11, 1863; killed in action, June 1, 1864, at Cold Harbor, Va. ; Also borne as Moffatt.

(applies as invalid on September 29, 1864; died November 20, 1889)

**BARDEN, HUMPHREY.**—Age, 26 years. Enlisted at Potsdam, to serve three years, and mustered in as private, Co. E , November 23, 1861; transferred to Co. D, no date; retransferred to Co. E, June 30, 1863; re-enlisted as a veteran, January 4, 1864; wounded in action, June 3, 1864, at Cold Harbor, V a . ; transferred to Co. D., Ninety-sixth Infantry, December 1, 1864. [B A R D E N , HUMPHREY.—Private, Co. E, Ninety-second Infantry, transferred to Co. D, this regiment, December 1, 1864, to Co. D, Third Regiment, Veteran Reserve Corps, February 15, 1865, from which discharged, November 11, 1865, at Brattleboro, Va.] (dies May 10, 1917 at Norwood, NY)

E, October 30, 1861; returned to ranks, September 1862; transferred to Co. D, June 11, 1863; re-enlisted as a Veteran, January 1, 1864; wounded in action, June 1, 1864, at Cold Harbor, Va.; mustered out, September 29, 1864. (died February 22, 1916 at Madrid, NY)
