ARMSTRONG, HENRY N.—Age, 22 years. Enlisted, August 12, 1862, at Starkey, to serve three years; mustered in as private, Co. B, September 14, 1862; promoted corporal in May, 1864; sergeant, October 13, 1864; captured, October 27, 1864; paroled, March 25, 1865; mustered out with company, June 22, 1865, at Richmond, Va. [ No Pension Application Found/NPAF ]

BARKER, EDWARD R.—Age, 30 years. Enlisted, August 20, 1862, at Naples, to serve three years; mustered in as private, Co. G, September 14, 1862; promoted sergeant, September 18, 1862; **wounded in action**, June 3, 1864, at Cold Harbor, Va.; **again, October 27, 1864**; promoted first sergeant, March 2, 1865; discharged as sergeant, July 26, 1865, at Elmira, N. Y.[ Applies as an invalid in September 1865 ]

BENNETT, MARTIN L.—Age, 18 years. Enlisted, December 18, 1863, at Ovid, to serve three years; mustered in as private, Co. G, December 22, 1863; wounded in action, May 15, 1864, at Drewry's Bluff, Va.; captured in action, October 27, 1864, at Fair Oaks, Va. ; paroled, no date; discharged, June 20, 1865, at Elmira, N. Y.[ Died April 18, 1914 at Grand Rapids, MI ]

BENTON, HENRY N.—Age, 21 years. Enlisted, December 9, 1863, at Elmira, to serve three years; mustered in as private, Co. B, December 31, 1863; **no record subsequent to October 27, 1864, as captured.** [ Father and Mother apply on January 7, 1880 ]

BIRD, LUCIUS P.—Age, 34 years. Enlisted at Waterloo, to serve three years, and mustered in as private, Co. H, August 28, 1862; promoted corporal, September 14, 1862; sergeant, April 1, 1864; first sergeant, October 15, 1864; captured in action, October 27, 1864, at Fair Oaks, Va.; paroled in March, 1865; joined and mustered out with regiment, June 27, 1865, at Geneva, N. Y.[ Died May 17, 1898 ]

BISHOP, ASHER W — Age, 24 years. Enlisted, September 6, 1862, at Manchester, to serve three years; mustered in as private, Co. K, September 14, 1862; promoted corporal, August 10, 1864; captured, October 27, 1864, at Fair Oaks, Va.; paroled, no date; **died, March 25, 1865, at Camp Parole, Annapolis; Md.** IN Brown as **Bishop, Ash M., Pvt., K, 148th NY, 2-2-65** [ Mother applies on May 20, 1891 ] [ NOT found at Annapolis National Cemetery ]

BRAINARD, EDWARD R.—Age, 21 years. Enlisted at Brooklyn, to serve three years, and mustered in as private, Co. B, August 26, 1864; **no record subsequent to October 27, 1864, as captured.** [ NPAF ]

BRAINARD, SEARES F.—Age, 42 years. Enlisted, August 30, 1862, at Seneca, to serve three years; mustered in as private, Co. D, September 14, 1862; wounded in action, June 3, 1864, at Cold Harbor, Va.; captured in action, October 27, 1864, at Fair Oaks, Va. ; died, November 26, 1864, at Salisbury, N. C. [ IN Brown as Branard, S. F., Pvt., D, 148th NY, 11-27-64 and possibly repeated as Bagnerd, S.F., Pvt., D, 148th NY, 12-20-64 ] [ Widow applies on April 28, 1865 ] [ See 14 pages at [www.fold3.com](http://www.fold3.com) ]

BROWNELL, SOLOMON.—Age, — years. Enlisted, December 25, 1863, at Cameron, to serve three years; mustered in as private, Co. B, January 25, 1864; wounded in action, June 18, 1864, near Petersburg, Va.; no record subsequent to October 27, 1864, as captured. [ Widow and minor apply on April 5, 1866 ] [ Died at Florence, SC, on April 20, 1865 according to John Hirsh, E, 88<sup>th</sup> NY. ] [ HUSH, JOHN.—Age, 21 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. D, March 19, 1864; captured in action, May 13, 1864, at Po River, Va.; paroled, no date; mustered out, July 10, 1865, at Elmira, N. Y. ; also borne as Hash.] See 86 pages of widow's pension at [www.fold3.com](http://www.fold3.com) ]

CONWAY, JOHN.—Age, 21 years. Enlisted, August 30, 1862, at Gorham, to serve three years; mustered in as private, Co. F, September 14, 1862; captured, October 27, 1864; paroled in February, 1865; absent, sick in hospital at muster-out of company. [ Mother applies on May 15, 1865 ] [ There is a John Conway buried at Annapolis National Cemetery, March 13, 1865, but attributed to New Jersey where one man comes up from the 10<sup>th</sup> NJ. Reg't.]

COOL, JAMES H.—Age, 18 years. Enlisted, August 31, 1862, at Seneca, to serve three years; mustered in as private, Co. D, September 14, 1862; captured in action, October 27, 1864, at Fair Oaks, Va., and absent at muster-out of company. [ IN Brown as Cool, J.H., Pvt., D, 140th NY, 12-18-64 ] [ Mother applies on April 29, 1865 ]

CORNELL, HARTMAN B—Age, 20 years. Enlisted at Wayland, to serve three years, and mustered in as private, Co. K, May 17, 1864; wounded and captured in action, October 27, 1864, at Fair Oaks, Va.; paroled, March 1, 1865, at Wilmington, N. C.; discharged, August 29, 1865, at Rochester, N. Y. [ Died April 1, 1920 at Romeo, MI ]

CROSBY, WILLIAM L.—Age, 18 years. Enlisted at Avon, to serve one year, and mustered in as private, Co. C, September 5, 1864; captured in action, October 27, 1864, and absent at muster-out of company. [ NPAF ] [ Died at Richmond, VA as POW on December 25, 1864 ] Left a Testament which was passed on to William Vidlene who died at Salisbury on February 4, 1865. The book then passed to Solomon Sullivan when he was sent to Richmond for exchange. DEAN, DANIEL C.—Age, 21 years. Enlisted, September 2, 1864, at Romulus, to serve one year; mustered in as private, Co. K, September 8, 1864; absent, missing in action since October 27, 1864, and at muster-out of company. [ NPAF ]

DEBOLT, JOHN.—Age, 25 years. Enlisted, August 21, 1862, at Milo, to serve three years; mustered in as private, Co. B, August 29, 1862; promoted corporal, September 14, 1862; sergeant, no date; absent, wounded and missing in action since October 27, 1864, and at muster-out of company; reported dead. [ NPAF ] [ See [www.militaryhistoryonline](http://www.militaryhistoryonline) Died in Richmond hospital from ankle wound /gangrene on November 29, 1864, according to gggrandson at above site.

DORSHEID, JOHN.—Age, 33 years. Enlisted, August 27, 1862, at Seneca Falls, to serve three years; mustered in as private, Co. H, September 14, 1862; wounded in action, October 27, 1864, at Fair Oaks, Va.; discharged, June 12, 1865, at hospital, Fort Monroe, Va.; also borne as Dorshied. [ Died August 14, 1901 but granted pension as an invalid in February 1866 ] ]

DOUGLASS, LEWIS.—Age, 44 years. Enlisted, August 26, 1862, at Phelps, to serve three years; mustered in as private, Co. C, September 14, 1862; absent, prisoner of war, since October 27, 1864, and at muster-out of company. [ Widow/minor apply April 28, 1865 ] [ Loren McMillin swears to Lewis's death at Salisbury on January 7, 1865. Re-marriage seems to have complicated matters making an 86 page file at [www.fold3.com](http://www.fold3.com) ]

DUNHAM, DAVID.—Age, 28 years. Enlisted, August 19, 1862, at Barrington, to serve three years; mustered in as private, Co. B, September 14, 1862; absent, wounded and missing in action since October 27, 1864, and at muster-out of company; reported to have died. [ Mother applies in May 1880 ]

ELWOOD, CHARLES H.—Age, 22 years. Enlisted, August 20, 1862, at Barrington, to serve three years; mustered in as private, Co. B, September 14, 1862; promoted corporal, no date; wounded in action, June 3, 1864, at Cold Harbor, Va.; absent, missing in action, October 27, 1864, and at muster-out of company; reported to have died at Salisbury, N. C. [ Mother applies on April 24, 1864---probably an error. 1865 is more likely ] [ James Foster swears to death on February 7, 1865 at Salisbury. FOSTER, JAMES E.—Age, 27 years. Enlisted, August 12, 1862, at Starkey, to serve three years; mustered in as private, Co. B, September 14, 1862; captured and paroled, no dates; discharged, May 25, 1865, at Elmira, N. Y. [ Captured at Fair Oaks on Oct. 27, 1864, see Charles Elwood, above. ] [ Died February 7, 1927 at St. Louis, MO ]

FOUNTAIN, JACOB W.—Age, 18 years. Enlisted, August 29, 1862, at Middlesex, to serve three years; mustered in as private, Co. F, September 14, 1862; captured, October 27, 1864; paroled in February, 1865; died of congestion of lungs, March 18, 1865, at Annapolis, Md. [ NPAF ] [ See [www.findagrave.com](http://www.findagrave.com) Section A, Site 156 ]

GAGE, E. DARWIN.—Age, 39 years. Enlisted at Geneva, to serve three years, and mustered in as **captain, Co. D**, September 1, 1862; wounded in action, June 15, 1864, near Petersburg, Va.; **killed in action", October 27, 1864, at Second Fair Oaks, Va.**

Commissioned captain, November 3, 1862, with rank from September 1, 1862, original; lieutenant-colonel, not mustered,

November 29, 1864, with rank from October 16, 1864, vice J. B. Murray, promoted. [ George Webb says Gage was killed by shellfire during a charge .He was acting Lt. Col. of the regiment at the battle, and his widow fought through 62 pages at [www.fold3.com](http://www.fold3.com) to be compensated as widow of Lt. Colonel. Pension file goes on through the 1890's ]

GOFF, BENJAMIN R.—Age, 29 years. Enlisted at Avon, to serve one year, and mustered in as private, Co. F, September 10, 1864; absent, prisoner of war, since October 27, 1864, at Fair Oaks, Va., and at muster-out of company. [ Possibly in Brown as Goff, B. F., Pvt., F, 140th NY, 12-20-64] [ Widow applies on July 10, 1865 ]Brother to Nathan Goff, below. [ Died at Salisbury on December 20, 1864. Only 10 pages of widow's pension file at [www.fold3.com](http://www.fold3.com) ]

GOFF, NATHAN A.—Age, 21 years. Enlisted, August 31, 1862, at Middlesex, to serve three years; mustered in as private, Co. F, September 14, 1862; promoted corporal, September 1, 1864; absent, prisoner of war, since October 27, 1864, at Fair Oaks, Va., and at muster-out of company. [ Father applies on March 11, 1886 ][ Older brother, Benjamin, stopped to tend to his wounded brother on the battlefield and was subsequently captured. Nathan was left on the ground where he fell. ]

GOODRICH, PETER.—Age, 34 years. Enlisted, August 29, 1862, at Naples, to serve three years; mustered in as private, Co. G, September 11, 1862; wounded in action, May 14, 1864, at Drewry's Bluff, Va.; again, no date, before Petersburg, Va.; captured in action, October 27, 1864, at Fair Oaks, Va.; paroled, March 8, 1865; discharged, June 14, 1865, at Elmira, N. Y. [ Died April 27, 1914 at Union City, MI ]

GRUNT, FRIEDRICH.—Age, 23 years. Enlisted, August 30, 1862, at Gorham, to serve three years; mustered in as private, Co. F, September 14, 1862; wounded in action, June 3, 1864, at Cold Harbor, Va.; captured in action, October 27, 1864, at Fair Oaks, Va.; paroled in February 1865; mustered out with detachment, May 30, 1865, at Elmira, N. Y., as Green. [ NPAF ]

HALLACK, STEPHEN K.—Age, 16 years. Enlisted, August 22, 1862, at Starkey, to serve three years; mustered in as musician, Co. B, September 14, 1862; grade changed to private, no date; absent, missing in action, since October 27, 1864, at Fair Oaks, Va., and at muster-out of company; also borne as Halleck.[ HALLOCK----Invalid pensioned on February 20, 1866; died April 20, 1908 ]

HARKNESS, DEROY J.—Age, 27 years. Enlisted at Gorham, to serve three years, and mustered in as private, Co. F, August 31, 1862; promoted sergeant, September 2, 1862; wounded and captured in action, October 27, 1864, at Fair Oaks, Va.; paroled in February, 1865; discharged, May 28, 1865, at hospital, Camp Lee, Va.[ Invalid pensioned in June 1865; died September 25, 1904 at Rushville, NY ]

HEFERON, MICHAEL.—Age, 19 years. Enlisted, August 18, 1862, at Phelps, to serve three years; mustered in as private, Co. C, September 11, 1862; wounded in action, October 27, 1864, at Fair Oaks, Va.; discharged, July 7, 1865, at hospital, Fort Monroe, Va.; also borne as Hefferan and Heffern. [ NPAF ]

HOFFMAN, GEORGE W.—Age, 20 years. Enlisted, August 27, 1862, at Fayette, to serve three years; mustered in as private, Co. D, September 14, 1862; captured in action, October 27, 1864, at Fair Oaks, Va.; paroled, no date; mustered out, June 29, 1865, at Elmira, N. Y. [ Died October 17, 1921 at Auburn, NY ]

HOUSEL, CHARLES W.—Age, 22 years. Enlisted, August 31, 1862, at North Bristol, to serve three years; mustered in as private, Co. G, September 14, 1862; promoted sergeant, September 21, 1862; first sergeant in November, 1863; **wounded in action, October 27, 1864, at Fair Oaks, Va.; died of his wounds, November 11, 1864, at Fort Monroe, Va.** [ Mother applies in May 1890 ]

JOHNSON, CHARLES JEFFERSON.—Age, 18 years. Enrolled, August 31, 1862, at Seneca Falls, to serve three years; mustered in as private, Co. A, September 5, 1862; promoted sergeant, September 11, 1862; mustered in as second lieutenant, Co. H, February 2, 1864; wounded in action, June 3, 1864, at Cold Harbor, Va.; mustered in as **first lieutenant, Co. C, October 15, 1864; wounded in action, October 27, 1864, at Fair Oaks, Va.;** discharged, May 14, 1865; also borne as Charles D. [ Applies as an invalid in June 1865 ] Commissioned second lieutenant, December 15, 1863, with rank from October 20, 1863, vice H. Parsons promoted; first lieutenant, September 10, 1864, with rank from August 27, 1864, vice H. H. Hopkins promoted; captain, not mustered, October 10, 1865, with rank from May 15, 1865, vice T. Roberts resigned.

LABOUYTOUX, WILLIAM.—Age, 29 years. Enlisted, August 25, 1862, at Yarick, to serve three years; mustered in as private, Co. D, September 14, 1862; **wounded in action, June 18, 1861, near Petersburg, Va.; absent, prisoner of war, since October 27, 1864, at Fair Oaks, Va., and at muster-out of company;** also borne as Laboytaux, and Laboytoux. [ Colonel John Murray testifies that he saw soldier **wounded in the head** and when the regiment fell back from a Rebel counter-charge, William was in the same position as when wounded. In May 1865, Col. Murray re-visited the scene and found remains (a skull with a bullet hole in it) that was in the same area, and that he believed it was Labouytoux's body. The widow remarried in 1874 and was abandoned by her new husband around 1882. By 1902, she obtained a divorce and was re-applying for a pension under her former husband. LABRAM, CHARLES.—Age, 35 years. Enlisted, December 19, 1863, at Johnsburgh, to serve three years; mustered in as private, Co. I, January 5, 1864; **died of typhoid fever, April 5, 1865, at Camp Parole Hospital, Annapolis, Md.** [ 51 pages at [www.fold3.com](http://www.fold3.com) There is some claim in 1937 that daughter makes saying he was "starved in Andersonville." However, more immediate documents make no mention of capture. He had six pensionable children at the time of his death and his widow was put through paperwork hell trying to prove her marriage and document the births and care for her children.][ Section N, Site 88 ]

LACKEY, ELISHA.—Age, 20 years. Enlisted, August 21, 1862, at Milo, to serve three years; mustered in as private, Co. B, September 14, 1862; **absent, missing in action, since October 27, 1861, near Fair Oaks, Va., and at muster-out of company; reported died at Salisbury, N. C.** [ IN Brown as Lackey, Elijah, Pvt., B, 148th NY, 2-13-65 ] [ Father and Mother apply without success in August 1865 ]

LAWTON, JOHN J.—Age, 21 years. Enlisted, August 25, 1862, at Middlesex, to serve three years; mustered in as private, Co. F, September 14, 1862; absent, prisoner of war, since October 27, 1864, and at muster-out of company. [ Sister applies, without success, in December 1883 ]

LEHMAN, GEORGE.—Age, 20 years. Enlisted, August 28, 1862, at Waterloo, to serve three years; mustered in as private, Co. H, September 14, 1862; captured in action, October 27, 1864, at Fair Oaks, Va.; paroled, April 2, 1865, at North East Bridge; discharged, July 20, 1865, at Rochester, N. Y. [ Died March 14, 1924 near Sligo, (?)

LERCH, GEORGE.—Age, 18 years. Enlisted, August 30, 1862, at Varick, to serve three years; mustered in as private. Co. D, September 14, 1862; promoted corporal, May 1, 1864; absent, prisoner of war, since October 27, 1864, and at muster out of company. [ NPAF ]

MEAD, HENRY R.—Age, 21 years. Enlisted, December 22, 1863, at Chester, to serve three years; mustered in as private, Co. I, January 5, 1864; wounded in action, June 3, 1864, at Cold Harbor, Va.; died of typhoid fever, April 7, 1865, at hospital, Camp Parole, Annapolis, Md. [ 15 pages at [www.fold3.com](http://www.fold3.com) No mention made of captivity. See Charles Labrum, above. ] [ NOT found at Annapolis ]

McMILLEN, LOREN.—Age, 29 years. Enlisted, August 25, 1862, at Phelps, to serve three years; mustered in as private, Co. G, September 14, 1862; captured in action, October 27, 1864, at Fair Oaks, Va.; paroled, no date; discharged, July 1, 1865, at Elmira, N. Y. [ NPAF ]

McWILLIAMS, ROBERT.—Age, 19 years. Enlisted, September 3, 1864, at Avon, to serve one year; mustered in as private, Co. D, September 7, 1864; wounded and captured in action, October 27, 1864, at Fair Oaks, Va.; absent since and at muster-out of company. [ NPAF ]

MITCHELL, ZACHARY.—Age, 18 years. Enlisted, August 8, 1864, at Naples, to serve one year; mustered in as private, Co. I, August 16, 1864; absent, missing in action since October 27, 1864, and at muster-out of company. [ NPAF ]

PARSONS, GEORGE H.—Age, 20 years. Enlisted, August 26, 1862, at Potter, to serve three years; mustered in as private, Co. F, September 14, 1862; wounded in action, October 27, 1864, at Fair Oaks, Va.; mustered out, June 9, 1865, at Elmira, N. Y. [ Appears to have died around July 1877 ]

REDFIELD, DANIEL W.—Age, 24 years. Enrolled, August 29, 1862, at Hopewell, to serve three years; mustered in as private, Co. K, September 5, 1862; promoted sergeant, September 14, 1862; first sergeant, April 2, 1863; wounded in action, June 18, 1864, near Petersburg, Va.; mustered in as second lieutenant, July 20, 1864; as first lieutenant, August 27, 1864; wounded in action, October 27, 1864, at Fair Oak, Va.; mustered out with company, June 22, 1865, at Richmond, Va. Commissioned second lieutenant, July 20, 1864, with rank from June 19, 1864, vice O. M. Adams, died of wounds received

in action; first lieutenant, September 16, 1864, with rank from August 26, 1864, vice J . G. Evenden discharged. [ Died February 3, 1918 at Marshalltown, IA ]

REED, ORRIN D.—Age, 22 years. Enlisted, February 29, 1864, at Geddes, to serve three years; mustered in as private, Co. K, March 17, 1864; captured in action, October 27, 1864, at Fair Oaks, Va.; paroled, March 30, 1865, at Aiken's Landing, Va.; discharged, July 15, 1865, at Rochester, N. Y.[ Died August 5, 1887 ]

REED, WILLIAM D.—Age, 18 years. Enlisted, August 29, 1862, at Hopewell, to serve three years; mustered in as private, Co. K, September 14, 1862; **wounded and captured in action, October 27, 1864, at Fair Oaks, Va.; paroled, no date; absent, sick, at muster-out of company.** [ Died December 20/23, 1920/23 ]

---

RITTAR, EDWARD.—Age, 32 years. Enlisted, August 22, 1862, at West Bloomfield, to serve three years; mustered in as private, Co. K, September 14, 1862; promoted corporal, January 10, 1863; captured in action, October 27, 1864, at Fair Oaks, Va.; paroled, no date; **died March 22, 1865, at Camp Parole, Annapolis, Md.**; also borne as Ritter.[ This 125 page pension file at [www.fold3.com](http://www.fold3.com) makes no mention of capture. See Labrum and Mead, above. Widow was apparently in the poorhouse in Canandaigua, NY in 1887 and her case went into Special Examination. ][ NOT found at Annapolis National Cemetery ]

RUPPRECHT, JOHN G.—Age, 38 years. Enlisted, August 27, 1862, at Seneca Falls, to serve three years; mustered in as private, Co. H, September 14, 1862; **captured in action, October 27, 1864, at Fair Oaks, Va.; absent, since, and at muster out of company.** [ *Possibly* in Brown as Rubrecht, Samuel, Pvt., F, 14th NY, 10-24-64 ][ Some question of whether wounded soldier died before capture. Several witnesses claim he died on the field where he was left due to the regiment's falling back. Was a Bavarian German who emigrated to the USA around 1855. An interesting case for widow who had to sue an acquaintance who claimed Rupprecht left a wife and child in Germany. Turns out the acquaintance was withholding bounty money belonging to the widow. She won a judgement and got her pension, too. 42 pages at [www.fold3.com](http://www.fold3.com) ]

SCHOTT, ABRAM M.—Age, 18 years. Enlisted, August 27, 1862, at Waterloo, to serve three years; mustered in as private, Co. H, September 14, 1862; wounded in action, June 3, 1864, at Cold Harbor, Va.; captured in action, October 27, 1864, at Fair Oaks, Va.; paroled in March, 1865; mustered out with company, June 22, 1865, at Richmond, Va.; also borne as Scholt.[ Died September 17, 1930 at Waterloo, NY ]

SEIGWALD, JACOB.—Age, 41 years. Enlisted at Avon, to serve one year, and mustered in as private, Co. B, September 12, 1864; **wounded in action, October 27, 1864, at Fair Oaks, Va.**; discharged, June 8, 1865, at Elmira, N. Y.[ Died March 12, 1912 ]

SMITH, CHARLES E.—Age, 20 years. Enlisted, August 25, 1862, at West Bloomfield, to serve three years; mustered in as private, Co. K, September 11, 1862; **wounded in action, October 27, 1864, at Fair Oaks, Va.**; discharged, August 8, 1865, at Elmira, N. Y. [ Died November 3, 1915 at West Bloomfield, NY ]

SMITH, ROBERT.—Age, 20 years. Enlisted, August 30, 1862, at Seneca, to serve three years; mustered in as private, Co. D, September 14, 1862; promoted corporal, June 1, 1864; **wounded in action, October 27; 1864, at Fair Oaks, Va.**; mustered out with company, June 22, 1865, at Richmond, Va.[ Died April 19, 1927 at Geneva, NY ]

STAHL, WILLIAM.—Age, 44 years. Enlisted, August 29, 1862, in Fayette, to serve three years; mustered in as private, Co. A, September 14, 1862; wounded in action, May 16, 1864, at Drewry's Bluff, Va.; captured in action, October 27, 1864, at Fair Oaks, Va.; **absent, since, and at muster-out of company.** [ NPAF ]

Stagers, James, Pvt., E, 148th NY, 12-14-64 [ NOT identified ]

A , August 1, 1864; as major, September 28, 1864; as **lieutenant-colonel, October 16, 1864**; mustered out with regiment, June 22, 1865, at Richmond, Va.  
Commissioned first lieutenant, November 3, 1862, with rank from September 5, 1862, original; adjutant, December 15, 1863, with rank from October 26, 1863, vice H. T. I count approximately 68 casualties here. Around 22 are noted as wounded/killed and around 13 are missing in action. The remainders were captured and 20-25 of them died in captivity or shortly after release and 18 survived. This is over 50% dead which is fairly common for Salisbury around this time.

Nonetheless, no absolute conclusions can be made about this list. It would appear that the regiment (or portion of it) went into a charge where they received quite a deadly Confederate volley and countercharge. Other sources say there were 84 total casualties at 2<sup>nd</sup> Fair Oaks and that overall, 24 enlisted men died in the hands of the enemy, a number I would consider very low considering the total 90 missing that Phisterer counts from June 15 to this disaster. But until better descriptions are uncovered, this study remains indefinite.

The 118<sup>th</sup> NY suffered a similar amount of casualties in the same matter.

The battlefield itself appears to be lost to suburban development not far from Richmond's airport. And General Godfrey Weitzel, who managed this sorry affair, would probably like it that way.
