ADCOCK, THOMAS H.—Age, 22 years. Enlisted, August 5, 1862, at Northumberland, to serve three years; mustered in as private, Co. F , August 12, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; **wounded and captured in action, February 20, 1864, at Olustee, Fla. ; no further record.** [ Mother applies for a pension in April 1880 ]

ALBACK, PHILIP.—Age, 27 years. Enlisted at Albany, to serve three years, and mustered in as private, Co. C, October 28, 1863; captured in action, February 20, 1864, at Olustee, Fla. ; **escaped from Andersonville, Ga., July 18, 1864**; mustered out, June 15, 1865, at Raleigh, N. C. [ Appears to have died around April 1888 ]

BAKER, CHARLES N.—Age, 25 years. Enlisted, August 8, 1862, at Greenfield, to serve three years; mustered in as private, Co. C., August 11, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; . wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled, February 26, 1865, at Goldsboro, N.C; mustered out, July 21, 1865, at hospital, Annapolis, Md. [ Died July 21, 1892 ]

BARNES, WALTER D.—Age, 23 years. Enlisted, August 9, 1862, at Moreau, to serve three years; mustered in as private, Co. F , August 19, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va., ; promoted, corporal, no date; wounded and captured in action, February 20, 1861, at Olustee, Fla.; **died, October 23, 1864, at Andersonville, Ga.** #11,343 at Andersonville National Cemetery/ANC. [ No Pension Application Found/NPAF ]

BENKER, HENRY.—Age, 32 years. Enlisted at Brooklyn, to serve three years, and mustered in as private, Co. F , August 31, 1863; wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled, no date; transferred to Co. C, Forty-seventh Infantry, June 17, 1865; also borne as Benkil. [BENKIL, HENRY. — Private, Co. F , One Hundred and Fifteenth Infantry; transferred to Co. E, this regiment, June 17, 1865; **wounded and captured in action at Olustee, Fla. , February 20, 1864**; also borne as Benkir; **no further record.** [ No Pension Application Found/NPAF ]

BENSON, WESSON.—Age, 21 years. Enlisted, August 5, 1862, at Edinburgh, to serve three years; mustered in as private, Co. C, August 14, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.. ; **wounded and captured in action, February 20, 1864, at Olustee, Fla.; died of his wounds, March 26, 1864, at Lake City, Fla., while a prisoner of war.** [ Pension for widow and four children—only four pages at [www.fold3.com](http://www.fold3.com) ]

BLACKWOOD, WILLIAM H.—Age, 18 years. Enlisted, August 12, 1862, at Saratoga Springs, to serve three years; mustered in as private, Co. G, August 19, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; wounded and captured in action, February 20, 1864, at Olustee, Fla.; **died at Andersonville, Ga., no date.** [ Died July 28 of typhus fever; # 4,076 at ANC ] [ NPAF ]

BUEL, GEORGE W.—Age, 21 years. Enlisted, August 11, 1862, at Oppenheim, to serve three years; mustered in as private, Co. E, August 15, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; again captured in action, February 20, 1864, at Olustee, Fla. ; **died, August 15, 1864, at Andersonville, Ga.** #5714 at ANC [ Was wounded; death date is given as November 1864 but not really known. See 33 pages of widow's pension at [www.fold3.com](http://www.fold3.com) ]

CARSON, ELISHA. — Age, 44 years. Enlisted at Glen, to serve three years, and mustered in as private, Co. A , July 30, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; captured in action, February 20, 1864, at Olustee, Fla.; **died, August 22, 1864, at Andersonville, Ga.** #6,433 as Cardon and Carson at ANC---Dysentery [ No Pension Application Found/NPAF ]

CHRISTY, PHILIP S.—Age, 36 years. Enlisted, August 5, 1862, at Milton, to serve three years; mustered in as private, Co. C, August 8, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; **wounded and captured in action, February 20, 1864, at Olustee, Fla.; died, while a prisoner of war, no date.** [ Pension commences from 16 December 1864, meaning he probably died at Andersonville although no details are available in three pages of widow's and children's pension at [www.fold3.com](http://www.fold3.com) ].

COLE, GEORGE D.—Age, 21 years. Enlisted, August 9, 1862, at Halfmoon, to serve three years; mustered in as private, Co. H, August 14, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled, October 18, 1864; mustered out with detachment, May 27, 1865, at Foster Hospital, New Berne, N.C. [ Lived to at least February 1912 ]

CONNOLY, THOMAS.—Age, 19 years. Enlisted at Brooklyn, to serve three years, and mustered in as private, Co. H , September 2, 1863; wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled, no date; transferred to Co. F, Forty-seventh Infantry, June 17, 1865. [ Lt. Clark writes that he “had his leg amputated by the rebels at Tallahassee.” ] [ Invalided in July 1865; no death date given ]

CRANDALL, RUSSELL.—Age, 21 years. Enlisted at Albany, to serve three years, and mustered in as private, Co. I, October 30, 1863; wounded and captured in action, February 20, 1864, at Olustee, Fla.; **died, July 6, 1864, at Andersonville, Ga.** #2,950 at ANC---Scorbutus [ NPAF ]

DAVIS, JOHN W—Age, — years. Enrolled, August 13, 1862, at Fonda, to serve three years; mustered in as **second lieutenant, Co. A** , August 20, 1862; **wounded and captured in action, February 20, 1864, at Olustee, Fla.**; mustered in as first lieutenant, to date April 14, 1864; **paroled, January, 1865; discharged for wounds, January 7, 1865.**

Commissioned second lieutenant, September 10, 1862, with rank from August 20, 1862 original; first lieutenant, April 7, 1864, with rank from February 24, 1864, vice W. Ferguson promoted.[ Died January 26, 1900 ]

DEGRAFF, CHARLES H.—Age, 20 years. Enlisted at Halfmoon, to serve three years, and mustered in as private, Co. H , July 21, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.; wounded and captured in action, February 20, 1864, at Olustee, Fla.; **died, August 18, 1864, at Andersonville, Ga.**, as De Graff. #6,283 at ANC---Chronic Diarrhea[ Lt. Clark writes that he was taken to Tallahassee hospital to recover from his wound before being sent to Andersonville. ][ See 28 pages of mother's pension at [www.fold3.com](http://www.fold3.com) On page 5, ten neighbors swear to her dependence on son and feebleness.]

DENSMORE, SYLVANUS.—Age, 21 years. Enlisted, August 11, 1862, at Greenfield, to serve three years; mustered in as private, Co. G, August 19, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.; promoted corporal, no date; wounded and captured, February 20, 1864, at Olustee, Fla.; **died, June 22, 1864, at Andersonville, Ga.**, as Densmore. #2,320 at ANC---chronic diarrhea [ Left widow and one child---see 36 pages at [www.fold3.com](http://www.fold3.com) ]

DOOLEY, THOMAS.—Age, 23 years. Enlisted at Tarrytown, to serve three years, and mustered in as private, Co. E , October 28, 1863; wounded and captured in action, February 20, 1864, at Olustee, Fla.; **died of fever, June 1, 1864, in Confederate hospital at Andersonville, Ga.** [ NOT found at ANC ][ NPAF ]

FAIS, JOHN.—Age, 26 years. Enlisted at Tarrytown, to serve three years, and mustered in as private, Co. A , October 27, 1863; wounded and captured in action, February 20, 1864, at Olustee, Fla.; **died of diarrhea, April 30, 1864, at Andersonville, Ga.** ; also borne as Faus. #7,412 at ANC as Face [ NPAF ]

FOX, ROBERT.—Age, 32 years. Enlisted, August 1, 1862, at Milton, to serve three years; mustered in as corporal, Co. C, August 8, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.; **wounded and captured in action, February 20, 1864, at Olustee, Fla.; died, June, 1864, while a prisoner of war.** [ In rebel hospital at Lake City, FL according to 44 pages at [www.fold3.com](http://www.fold3.com) ]

GILLINS, JOHN.—Age, 22 years. Enlisted, August 1, 1862, at Amsterdam, to serve three years; mustered in as private, Co. D, August '2, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled February 25, 1865, at Wilmington, N. C.; mustered out,

June 15, 1865, at hospital, Division No. 2, Annapolis, Md., as Gillens.[ Died in 1907 ]

GITTINGS, JAMES H.—Age, 19 years. Enlisted, August 11, 1862, at Waterford, to serve three years; mustered in as private, Co. H , August 18, 1862; captured in action, September 16, and paroled, September 16, 1862, at Harper's Ferry, Va. ; promoted corporal, no date; wounded and captured in action, February 20, 1864, at Olustee, Fla.; **died, August 25, 1864, at Andersonville, Ga.**, as **Gettings** or Giddings #6,942 at ANC---diarrhea[ NPAF ]

GREEN, JAMES.—Age, 21 years. Enlisted, August 13, 1862, at Minden, to serve three years; mustered in as private Co. B, August 15, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; promoted corporal, January 6, 1864; wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled, no date; mustered out, May 22, 1865, at hospital, Annapolis, Md. [ Died January 15, 1923 at Bath, NY ]

HAGADONE, HARMON.—Age, 39 years. Enlisted, August 8, 1862, at Saratoga Springs, to serve three years; mustered in as corporal, Co. G, August 19, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.; returned to ranks, October 13, 1862; wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled, December, 1864; mustered out with detachment, May 27, 1865, at Foster Hospital, New Berne, N.C., as Hagadon; also borne as Hagedorn.[ Invalided in 1865; died May 27, 1903 ]

HARTT, GEORGE.—Age, 40 years. Enlisted, July 27, 1862, at Glen, to serve three years; mustered in as private, Co. A , July 28, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.; wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled and sent to Annapolis, Md., no dates; also borne as Hart; **no further record.**[ Lt. Clark says he died at Andersonville. ][ NPAF ]

#2,510 HOLLANDS, H. Co. E **died June 26, 1864 at Andersonville**---not found in NYSAG roster but Lt. Clark confirms his name without saying where he was captured. Another source says Olustee. [ NPAF ]

#10,978 HUNTER, J.H. Co. ? **died at Andersonville on October 15, 1864**--- not found in NYSAG roster

JERMAIN, JAMES.—Age, 23 years. Enlisted, August 11, 1862, at Milton, to serve three years; mustered in as private, Co. I , August 12, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.; wounded and captured in action, February 20, 1864, at Olustee, Fla.; **died, August 27, 1864, at Andersonville, Ga.** #6,966 as Jarmin at ANC---scorbutus [ NPAF ]

JOHNSON, HENRY.—Age, 42 years. Enlisted at Tarrytown, to serve three years, and mustered in as private, Co. I, October 30, 1863; wounded and captured in action, February 20, 1864,

at Olustee, Fla. ; **died, August 17, 1864, at Andersonville, Ga.** #5,916 at ANC---Chronic diarrhea [ NPAF ]

#10,614 KILSON, J. Co. E **died October 10, 1864 at Andersonville**--- not found in NYSAG roster [ NPAF ]

KIRKHAM, AMBROSE W.—Age, 29 years. Enlisted, August 14, 1862, at Glen, to serve three years; mustered in as private, Co. A , August 18, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.; wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled, no date; discharged for disability, May 20, 1865, at Chester, Pa. [ Invalided in June 1865; appears to have died around that time ]

LASHER, JOHN.—Age, 20 years. Enlisted at Palatine, to serve three years, and mustered in as private, Co. A , August 18, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled, no date; absent in General Hospital, Chestnut Hill, Philadelphia, Pa., at muster-out of company. [ Died January 24, 1915 at Williston, NY ]

MAXFIELD, RICHARD.—Age, 21 years. Enlisted, July 28, 1862, at Minden, to serve three years; mustered in as private, Co. B, August 7, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; wounded and captured in action, February 20, 1864, at Olustee, Fla.; exchanged, November, 1864; absent, sick, at muster-out of company. [ **“He died on the cars when near home, from the effects of starvation and cruel treatment, and was buried at Minden.”** Lt. Clark ] [ NPAF ]

McDOWELL, JOHN H — Age, 38 years. Enlisted at Goshen, to serve three years, and mustered in as private, Co. A , October 7, 1863; wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled, no date, transferred to Co. A, Forty- seventh Infantry, June 17, 1865; also borne as McDonald. McDOWELL, JOHN H.—Private, One Hundred and Fifteenth Infantry; transferred to Co. A , this regiment, June 17, 1865; captured in action, February 20, 1864; paroled, no date, at Annapolis, Md., at muster-out of company. [ Minor applies for pension in October 1869 ]

NIEDERLANDER, FRANK. — Age, 27 years. Enlisted, August 2, 1862, at Minden, to serve three years; mustered in as private, Co. B, August 11, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.; captured in action, February 20, 1864, at Olustee, Fla.; **reported dead on casualty list.** [ NPAF ]

PEELER, DANIEL. — Age, 35 years. Enlisted, August 21, 1862, at Palatine, to serve three years; mustered in as private, Co. I , August 23, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.; wounded and captured in action, February 20, 1864, at Olustee, Fla.; **died of typhoid fever, June 22, 1864, at Andersonville, Ga.** #2,321 as Puley at ANC [ See 96 pages of widow's pension at [www.fold3.com](http://www.fold3.com) ]

REES, THOMAS.—Age, 23 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. I , August 25, 1863; wounded and captured in action, February 20, 1864, at Olustee, Fla.; **died at Andersonville, Ga., no date.** [ NPAF ]

[ Rackmyer---invalided in 1865; died march 15, 1905 ]

E, August 15, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; **wounded and captured in action, February 20, 1864, at Olustee, Fla.; died, November 10, 1864, in Confederate hospital, at Tallahassee, Fla.**[ NPAF ]

SHULTZ, RICHARD.—Age, 26 years. Enlisted at Albany, to serve three years, and mustered in as private, Co. F , October 28, 1863; captured, February 9, 1864; paroled, no date; transferred to Co. G, Forty-seventh Infantry, June 17, 1865; also borne as Schultz. **SCHULTZ, RICHARD.—Private, Co. F, One Hundred and Fifteenth Infantry; transferred to Co. G, this regiment, June 17., 1865; absent, prisoner of war, since February 9, 1864, and at muster-out of company.**[ NPAF ]

SIMPSON, JOHN H—Age, 33 years. Enlisted, August 8, 1862, at Florida, to serve three years; mustered in as private, Co, D, August 15, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.. ; **wounded and captured in action, February 20, 1864, at Olustee, Fla.; died, April 1, 1864, at Andersonville, Ga.** [NOT found at ANC ][ Pension file more reasonably asserts that he died in rebel hospital at Tallahassee on March 19 from wound in the hip. F , August 19, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.; appointed wagoner, no date; (“severely”)wounded and captured in action, February 20, 1864, at Olustee, Fla.; **died, June 27, 1864, at Andersonville, Ga.** #2,543 at ANC---typhus fever [ See 37 pages of widow’s pension at [www.fold3.com](http://www.fold3.com) ]

STEINBAUER, JOHN G.—Age, 36 years. Enlisted, August 4, 1862, at Milton, to serve three years; mustered in as private, Co. I, August 7, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va. ; **wounded and missing in action, February 20, 1864, at Olustee, Fla.**;also borne as Sternbaner; **no further record.**[ **Lt. Clark says he died at Andersonville, no date. A, this regiment, June 17, 1865; captured, March —, 1864; paroled, no date; absent, a paroled prisoner of war, at muster-out of company. [ “Supposed to be dead” according to Lt. Clark ] [ NPAF ]**

WHERRY, DAVID.—Age, 18 years. Enlisted at Goshen, to serve three years, and mustered in as private, Co. May 1, 1865; mustered out with detachment, June 12, 1865, at Raleigh, N.C. [ Died September 20, 1914 at Belding, MI ]

WILEY, WILLIAM H — Age, 22 years. Enlisted, July 28, 1862, at Johnstown, to serve three years; mustered in as private, Co. G, August 21, 1862; captured in action, September 15, and paroled, September 16, 1862, at Harper's Ferry, Va.; again wounded and captured in action, February 20, 1864, at Olustee, Fla.; died, September 2, 1864, at Andersonville, Ga., as Whiley. #7,622 at ANC---chronic diarrhea [ See 41 pages at [www.fold3.com](http://www.fold3.com) ]

YOUNGS, GEORGE.—Age, 21 years. Enlisted at Kingston, to serve three years, and mustered in as private, Co. E, October 27, 1863; wounded and captured in action, February 20, 1864, at Olustee, Fla.; paroled, no date; transferred to Co. C, Forty-seventh Infantry, June 17, 1865. **YOUNGS, GEORGE.—Private, Co. E, One Hundred and Fifteenth Infantry; transferred to Co. C, this regiment, June 17, 1865; captured and paroled, no dates; absent, a paroled prisoner of war, at muster-out of company. [ NPAF ]**

66 names here---However, Official Records records 1 officer and 58 enlisted men as missing at Olustee and Phisterer tallies 1 officer and 45 men missing. My feeling is that the true numbers are closer to 50 specifically for Olustee.

29 or more died at Andersonville, many of them listed as wounded.

11 or more died of wounds in Confederate hospitals at Lake City and Tallahassee.

15 or less survived captivity at Andersonville.

The Official Records gives 2 officers and 27 men killed and 4 officers and 204 men wounded, totaling 6 + 231. Phisterer gives 2 officers and 60 men KIA or died of wounds, with a grand total of 296 casualties. This is quite a difference. I believe Phisterer is more accurate given the clearing off some fog of war in ensuing years.
