Tuesday November 24th/63

Bought this book of Rogers today. This morning we got orders to move about 4 o'clock. It commenced to rain about daybreak and about 7 o'clock we put up our tents again.

Wednesday Nov. 25th

In the same old place. It is a fine day to day. I hope we wont have to move. The Quarter Master has his things packed yet. Sent home \$30.00 this pay and have not heard from any of it yet. Ten of it was in a letter to Aunt Lydia and twenty was by Adams' Express Co. to Uncle Charles.

Thursday Nov 26th

This morning about 8 we got orders to move. We started and crossed the Rapidan about 7 o'clock that night. We went into camp close to the River.

Friday 27th

We left camp about 8 o'clock and went up to Cedar Grove where we got about 3 o'clock. The 2nd and 3rd Divisions were fighting at the time. We were ordered up on the left and we had not been in line more than an hour when we got into it too. We were fighting about an hour when it came on night. We were ordered out into the field to the front of where we were and we staid there all night on picket.

Saturday Nov 28th

This morning we were ordered to move about day light. We had only got about 4 miles when it began to rain and it continued to rain almost all day long. We went up beyond Robinsons Tavern on the road to Orange Court House to Mountain Run. And went into line of battle.

Sunday Nov 29th

Last night about dark our Co. and Co.[M?] were sent out on picket. We were out all night last night and all day today. We advanced our lines this afternoon to the edge of the creek.

Monday Nov 30th

On picket all night last night. We were relieved this morning about 9 o'clock and We went back into a field to support a battery. We lay here all day.

Tuesday Dec. 1st

We were supporting a battery all night and this morning about 7 o'clock we were still out in picket again. We were on the reserve this time. About 8 o'clock at night we got orders to pack up all our things so as they would not make any noise for we were agoing to fall back some time in the night.

Wednesday Dec 2nd

About 3 o'clock this morning we started to fall back. Our Reg^t and the 3rd Mich. And 20th Ind. Were the rear guard of our Corps. We got down to Germania Fort about 7 [1?] o'clock this morning a distance of 10 or 11 miles and we stopped about a mile this side of the River and made our coffee. As soon as we got it made and dank we started for our old camp at Brandy Station. We got to our

old camp at 3 o'clock precisely a distance of 20 miles making about 30 miles in just 12 hours.

Thursday Dec 3rd

In our old camp at Brandy Station.

Friday Dec. 4th

Last night about 10 o'clock the pack up call blew so we all packed up and fell in line. After laying around for a couple of hours we were ordered to pick up our tents again and they say we are going into winter quarters here. Got a letter from Annie this morning. Will answer it today. This afternoon there was another man shot in front of the whole Division.

Saturday Dec. 5th

This afternoon about 3 o'clock the pack up call blew again and we all got ready to move but we did not move but we got orders not to unpack anything and be ready to move at a moments notice.

Sunday Dec. 6th

This morning after inspection we moved our camp around a little different from what it was and we took our position on the right of the regiment. Got a letter from Aunt Lydia and one from Uncle Charles on Saturday afternoon. Wrote home to Aunt Lydia this afternoon.

Monday Dec. 14th

Got a letter from Annie last night. Went over and saw Jimmy Nash today. Will write to Annie today.

Friday Dec. 18th

Went over to Hd Qrs of 3rd Div 6th Corps today to see [Ins?] Reed. He is on Provost Guard there. He and Wright Bisbee are the only ones left in the 7th that I know now. Wright is now Capt of Co. D. 7th Mass. Vols. [Moty?] is in hospital in Washington from a wound he got at Gettysburg last July.

January 14th 1864

Today got paid \$300. (by [Orison?] Blount) County Bounty. Gave Tom Bannon \$233 of it to keep for me and give me as I want it. Bought a Silver Watch today.

Sunday May 1st

Wrote to Annie in the afternoon.

Monday 2nd

Got a letter from Annie tonight.

Tuesday 3rd

Wrote to Annie in the afternoon. Today we got orders to move and at 11 o'clock we started. We marched all night long.

Wednesday 4

Today we marched until about 3 o'clock in the afternoon when we came to the old battle ground of Chancellorsville and we went into Camp close to the place where we made the morning's excursion a year ago. We have had one of the hardest marches we ever had. I never was used up so bad before in my life.

Thursday 5th

This morning at Sun rise we started and came away around toward Fredericksburg and then we turned off towards our right and we came about 8 or 10 miles. At about ½ past 9 we halted in a big field and here we are now waiting for orders I suppose. Started from there about ½ past 11 and took the road back towards Chancellorsville for about 3 miles when we kept on bearing to the left for about 3 or 4 miles further when we formed in line of battle. We had two [times? tries? turries? in front of us.. We got into it about 4 o'clock when an Orderly Serg^t got wounded I started to help him out when I got wounded took a rebel bay^t [reg^t?] which turned our right flank it was the 21st South Carolina. We are now in a fine woods in a field about 2 miles from Chancellorsville.

Sunday May 8th

Today we are in the same piece of woods. Last night they sent away a great many of the wounded in Army wagons as they had not enough ambulances to carry all of them. We expect every moment that the rebels will be here and take us prisoners.

Monday 9th

We are still laying here in the same place and have not seen the Rebels yet

Tuesday 10th

Yesterday afternoon there was a squad of rebels came here to us and they say we are all prisoners. I do not know how true it is for we have not seen any of them since. We still in the same place.

Wednesday 11th

We are still in the same place yet. Have not seen any more Rebels since those left us day before yesterday. There was very heavy Artillery firing going on all day up on the Right of us I should think it was. It was to the South'ard and East'ard of us. Everything is very quiet this morning so far.

1/4 to Eleven in the forenoon

There was a Sergeant of our Cavalry came in just now with a flag of truce. Do not know what is going to be done.

Thursday 12th

This day week I was wounded and have been in the same place ever since. There has been about the heaviest cannonading going on all day long that I ever heard. It has slacked up a little now. (3 p.m.) It is up about Hanover C. N.[?] they say. It appears to be about 15 or 20 miles off from here.

Friday 13th

This morning there were 8 Wagons come to us from Fredericksburg with Supplies and medical stores. The Teamsters say we are better off here than we would be in F. because there are so many wounded there that there is hardly any accommodation for them. They are sending away the wounded however as fast as they can get transportation for them. So we may expect to get away from here in a week or two. We are still in the same old place yet. This afternoon Col. White and a party of his Guerillas came and made us a visit. They broke up all the Arms they could find around the Hospital and destroyed the Equipments and all the Ammunitions and took our Doctors (Evans) horse and went away but our Doctor went after them and got a horse from them in place of his.

Saturday 14th

Still in the same place Nowell[?] one of our buglers went back to Chancellorsville last night and Dr. Porter told him there was 20,000 of our wounded in Fredericksburg now. There is just 300 of us here now. There don't seem to be much chance of our getting away from here before the middle of next week if we do then. This afternoon about 4 o'clock there came 60 Cavalry Ambulances from Fredericksburg and took away most if not all of the wounded of the 2nd Division of our Corps. We will go in a few days I expect. I hope so anyway.

Sunday 15th

Still in the same pace yet. About ½ past ten this forenoon another squad of Rebel Cavalry came here and went off towards Chancellorsville. They had not been gone from here long when we heard firing between them and our pickets. It did not last long. They are firing away this morning away up where the army is.

Monday 16th

Still in the same old place yet. Everything has been very quiet here all day.

Tuesday 17th

Still in the same old place yet. Everything very quiet all day. We have got out of rations now. We have got no more coffee or meat and all we have to eat now is hard tack and water.

Wednesday 18th

Still in the same place yet. We have only had hard tack to eat all day. The Doctor and Dick Dillion and Bill Paine went to Fredericksburg this morning with a flag of truce and they have not got back yet (4 o'clock).

Thursday 19th

This morning at ½ past 8 Doctor Evans came back from Fredericksburg and he brought 26 ambulances and 2 wagonloads of grub. The ambulances took away about all of our worst cases and some of the light ones. About 100 went away in all I guess. Doctor Evans left Nowell back at our reserve picket post to pilot another train of ambulances in here that they was agoing to send out to us and take us all away. They have not got here yet at noon but I hope they will come before night.

Friday 20th

Today there were 60 ambulances came out and brought the most of us into Fredericksburg. We are not much better off here than we were out there in the field. I hope we get sent away from here soon.

Saturday 21st

Wrote home to Annie today. Am in Fredericksburg yet. In the afternoon Sharpe and I were first into an ambulance again and we were drove out about a mile and put into the 2nd Corps Hospital. We are just outside of the city and are in a fine airy place.

Sunday 22nd

Today am down in the 2nd Corps Hospital. It is about a mile from the City so I am told. We expect to be sent to Wash. as soon as they get the R.R. done to Falmouth which they say will be done in a few days. I hope so for we don't get any too good usage here.

Monday 23rd

In the same place. Got a new nurse in our ward last night and today we have been looked after a little better than heretofore.

Tuesday 24th

Am still in the same Hospital yet and our nurses grow worse and worse every day. I do not believe that any one was hardly ever so unlucky as we have been as regard Doctors Nurses and Attendance. One of our nurses is about laid up with the Rheumatism and the other one he swears that he would do anything for one half of us and what little he does do he growls so much about it that anyone would sooner not have him do anything for them. [Note in the margin: That nurse belongs to the 69th P.V.] And if you say anything to the Doctor he will give you no satisfaction. We are under charge of a Dr. Church from N.J. he is not worth a pin and he seems to care about that much worth for us.

Wednesday 25th

Wrote home to Annie today. Still here yet.

Thursday 26th

Last night I was taken down to the Transport Key Store about 8 o'clock and got aboard about 10 or 11 this morning. We got down to Port Royal and here we are laying now what for though I don't see.

Friday 27th

This morning about 8 o'clock started from Port Royal.

Saturday 28th

This morning we got to Washington and about 8 o'clock I was taken off and put aboard of some little open cars and was brought up to the Armory Square Hospital. I am in Ward B.

Sunday 29th

Sent a letter to Annie today.

Tuesday 31st

Am getting along pretty well. It is a pretty good Hospital but I guess there are better ones in the City. The grub is nothing extra but it will do.

Wrote to Annie in the afternoon. Abed still. Got a letter from Annie in the evening.

Friday 3rd

Am still abed. My hip swelled up last night again as it did when I was home.

Saturday 4th

My wound has discharged the worst looking and smelling pus for the past two[this is correct he forgot a word] that it ever had since I have been wounded. This morning when the Doctor came around he probed my wound and he found a couple of pieces of bone and after a good deal of hard pulling he got them both out. It was mighty hard work for me to bear it. Got a letter and a paper from Annie in the forenoon.

Sunday 5th

Wrote to Annie in the afternoon and sent her a paper too.

Monday 6th

Got up this morning. To night my wound looked the best that it ever did and it had run the least of any time yet.

Wednesday 8th

Went out on pass today. Got a letter from Annie in the afternoon. Wrote to Annie in the evening 8th.

Thursday 9th

Charlie Howland came to see me today. Began to walk on my wounded leg yesterday.

Sunday 12th

Got a letter from Annie in the morning and wrote to her and sent her a paper.

Monday 13th

Went out on pass today with Chute and bought me a Cane.

Wednesday 15th

Was recommended for a Discharge this morning by Dr. Kennon. Got a letter from Annie in the afternoon.

Wednesday 16th

Wrote to Annie in the morning.

Got a letter from Dunlap day before yesterday. Have not heard from my Discharge yet.

Saturday 18th

Was examined today for my Discharge and am to get it.

Monday 19th

Wrote to Annie and sent her a paper too.

Tuesday 21st

Went out on pass today. Got a letter from Annie and one from Aunt Lydia.

Wednesday 22nd

Wrote to Annie and Aunt Lydia in the afternoon. Went out on pass yesterday and hurt my leg for it is so sore today that I can hardly be around.

Tuesday 28th

Today there was about 200 wounded brought into the Hospital from City Point. Went out on pass yesterday with Fairbanks. 10 mos. yesterday since I was brought here.

Wednesday 29th

Got a letter from Annie this morning. Wrote to her in the forenoon. Went out on pass with Chute after dinner.

Thursday 30th

Got my papers today but will have to go before Dr. Bliss yet before I get them for good.

Friday 31st

Was examined this morning by Dr. Bliss for my Discharge and he said he would sign it.

Wrote to Annie in the afternoon. Went out on pass today with Chute.

Wednesday 5th

Got a letter from Annie in the morning. 11 mos. ago today I was wounded. Wrote to Annie right off. Went out on pass with Fairbanks.

Saturday 8th

Went out on pass. Had a touch of the Erysipelas tonight but I painted it this and I guess put a stop to it.

Sunday 9th

Got a letter from Annie in the morning. Wrote to Annie in the afternoon.

Monday 10th

Got my Discharge this morning. Went up to the Special Relief Dept. of the Sanitary Commission to get my pay but will have to go to the Pay Master General office first. Sold my crutches today for \$3.00.

Discharged by reason of gun shot fracture of right Trochanter major of right femur resulting in contraction of glutei muscles, adbuctus muscles, and inability to use the limb, thereby incapacitated for any duty.

Tuesday 11th

Went up to the P.M. Gen^I Office and then had to go to Maj. King and then come back and then go to Maj. Brooke and from there to the Adj. Gen. Off. and from there back to the P.M. Gen. It is the greatest running about that I ever I saw. Got paid this afternoon by Maj. Taylor \$418.70. Paid Tom Edmond \$2.00 and Boyle \$0.50 cts.

Wednesday 12th

Today got my pension papers made out up to the Sanitary Commission and wrote to Capt. J.R. Manser [Mauser?] for a certificate. Bought tickets for Boston at \$11.00. Went out to the Theatre last night.

Thursday 13

Left Washington last night at 6 o'clock and got into New York at 5 this morning and was to take the 12-15 train but going down to hunt up Tom Bannon. I got left and will take the 8 o'clock train tonight. Bought an Album for Barbara. \$3.50. Do not know what in the world to get for Mother.

Friday 14th

Got into Boston this morning at just 6 o'clock exactly. Got home to Abington at 4 o'clock and am now a citizen of the U.S.







Discharged at Brandy Station, Va., by reason of re-enlistment as a Veteran volunteer. Transferred to Co. E., 40th Inf. N. Y. Vols., from which he was diicharged [sic], as a Corporal, at Armory Square hospital, April 10, 1865, by reason of a gun shot wound received in battle.

Length of service 3 years, 5 mos., 3 days.

He was in the battles of Yorktown, Williamsburg, Seven Pines, Fair Oaks, Robinson's Farm, Seven days fight before Richmond, [two at Charles City Cross roads and Malvern Hill,] Bull Run, Chantilly, Fredricksburg, Ashby's Gap, Chancellorsville, Kelly's Ford, Orange Grove, Mine Run, and the Wilderness. Received gun shot wound in right hip in latter, may 5, 1864.

His widow states that Sergeant John F. Laxey and Thomas Bryson were his most intimate comrades in the service.

Comrade Cobb was mustered into the Post Feb. 25, 1869.

Died Dec. 29, 1871, at Wakefield, Mass.




