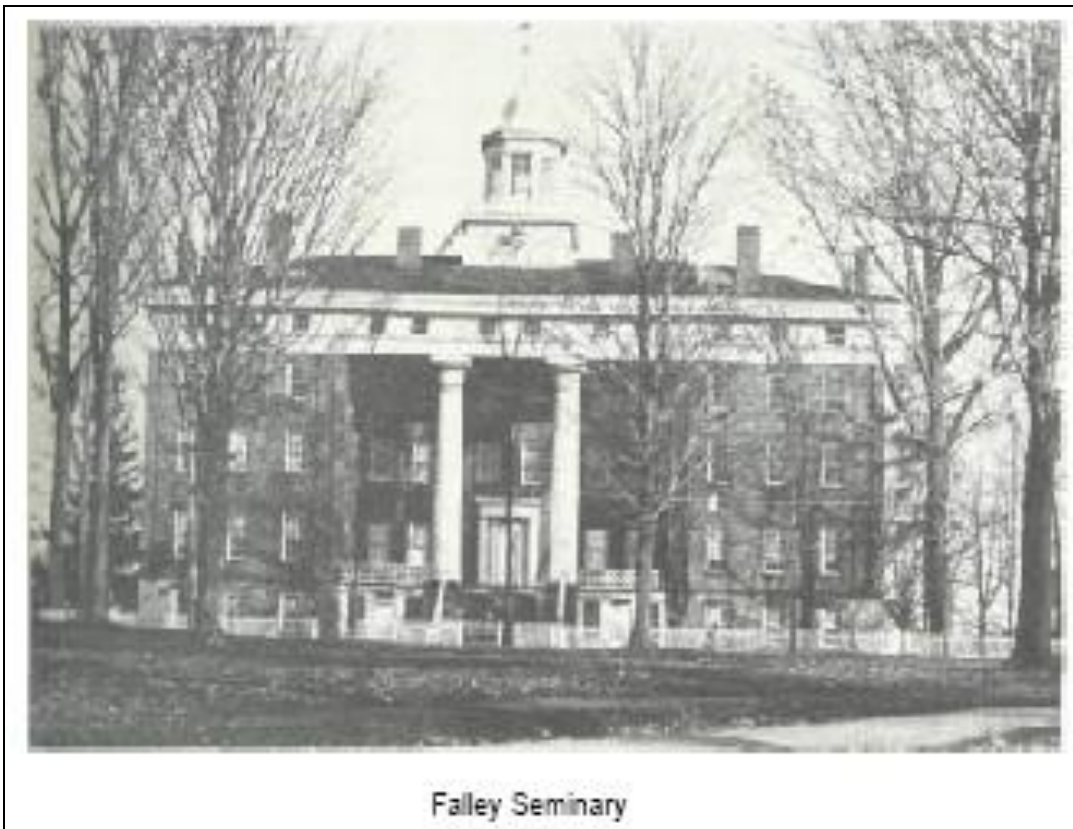

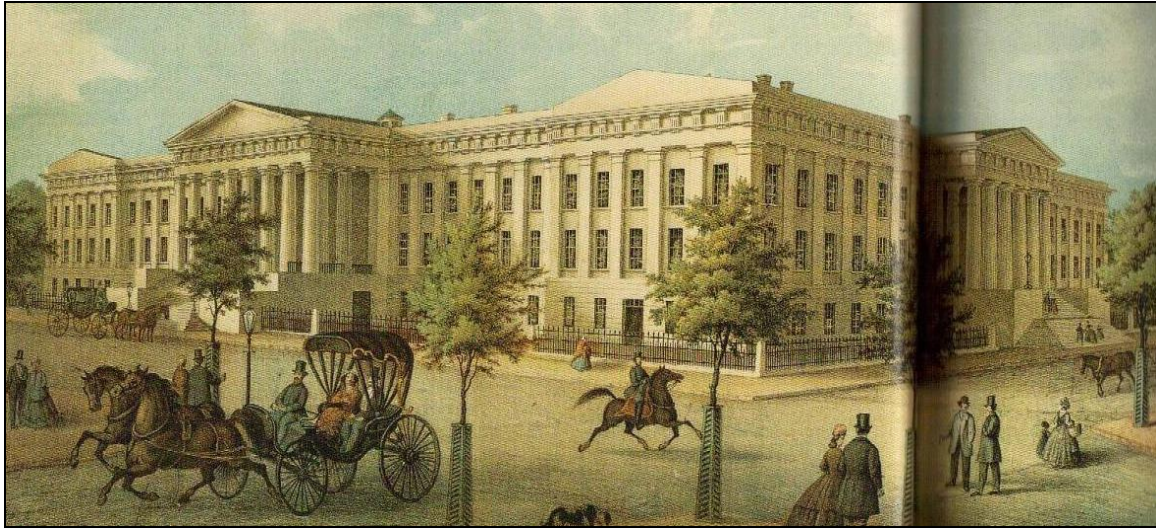


Historical sign for Chemung Canal Bank and Franklin Street (across the Chemung River), Elmira where the Dewitt family lived during the 1850s

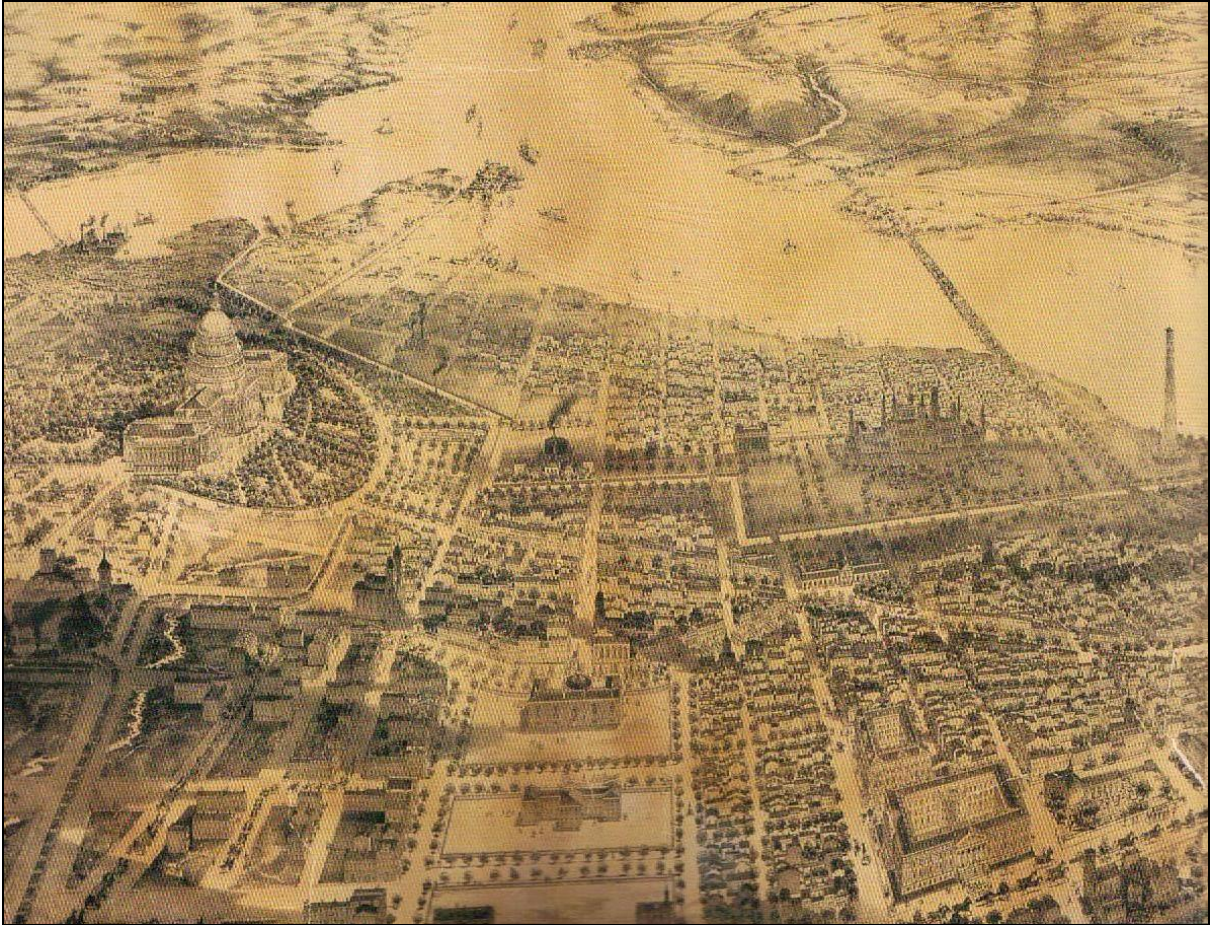

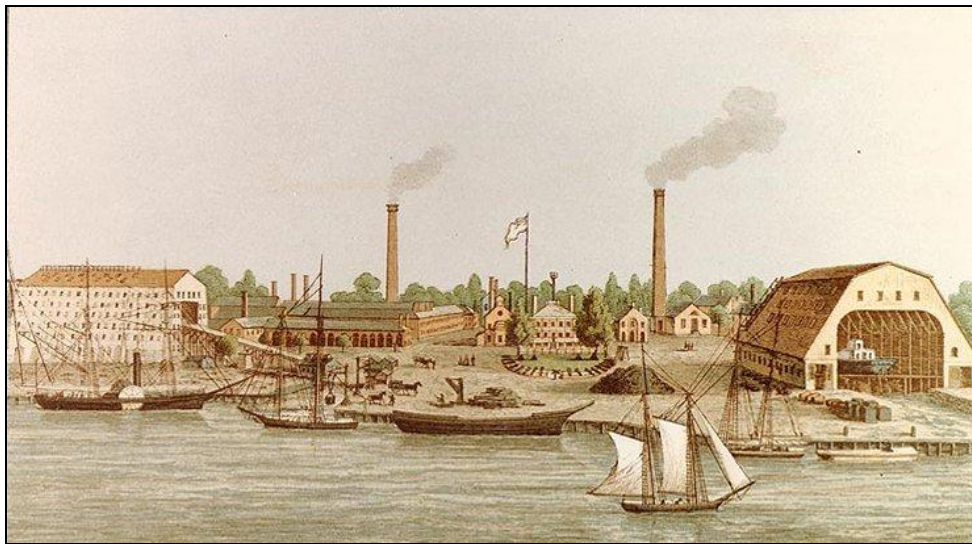

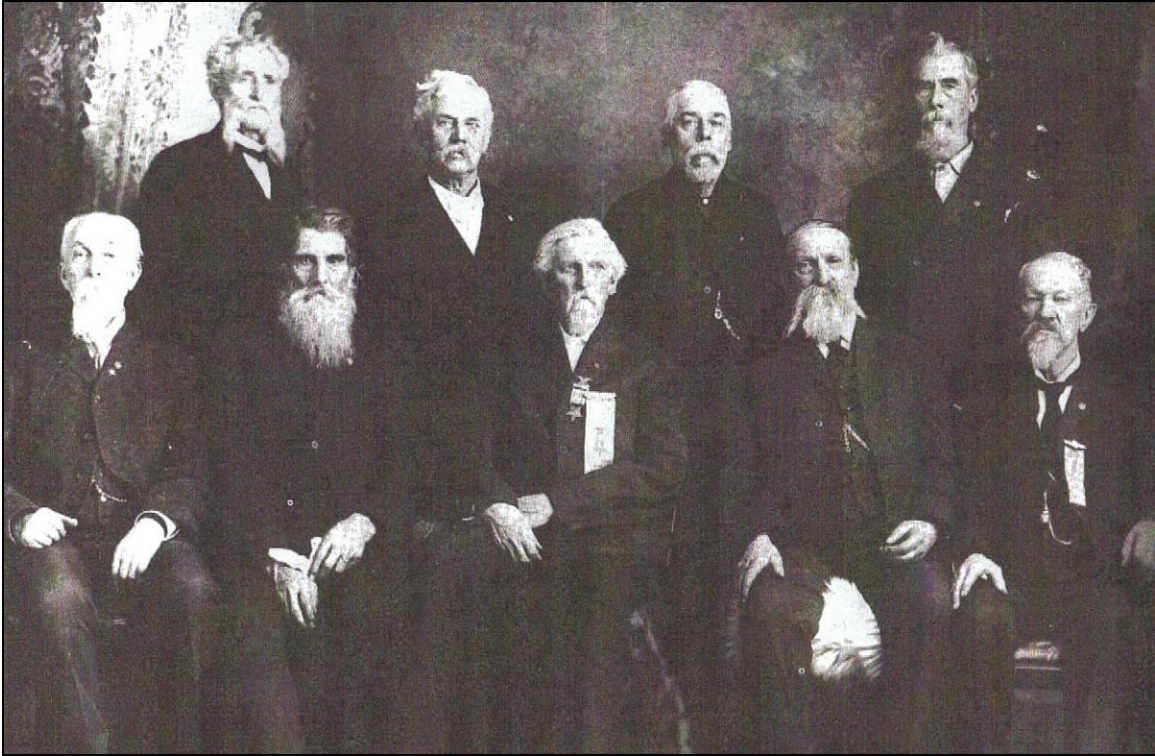

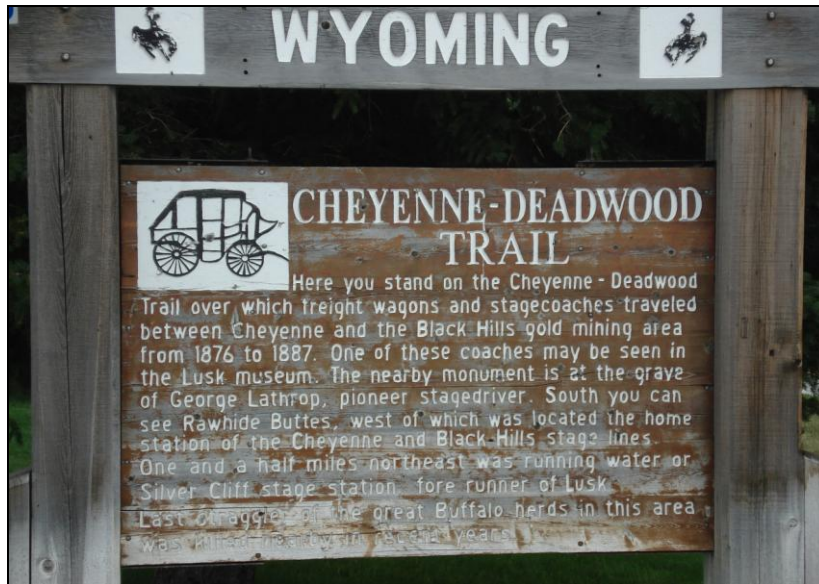

The People of the Territory of Wyoming to any Person authorized to Solemnize Marriage, Greeting:

*You are hereby authorized to join in the Holy Bonds of Matrimony and to celebrate within this County the Rites and Ceremonies of Marriage between*

*Mr. Phillip H Scriber of Laraine County Wyo and*

*Miss Christine Nelson of Laraine County Wyo and*

*this shall be your good and sufficient Warrant; and you are required to return this License to me, within three months from the celebration of such Marriage, with a Certificate of the same appended hereto, and signed by you, under a penalty of Five Hundred Dollars.*

*IN WITNESS WHEREOF, I have hereunto set my hand and the seal of said County, this 18th day of May 1889.*
