ABBOTT, GEORGE A.—Age, 18 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. K, October 10, 1861; promoted corporal, April 3, 1863; transferred to Co. A, June 25, 1863; wounded, July 3, 1863, at Gettysburg, Pa.; re-enlisted as a veteran, December 21, 1863; returned to ranks, April 1, 1864; **wounded, June 22, 1864, near Petersburg, Va.**; mustered out with company, June 30, 1865, at Munson's Hill, Va. [ Died July 11, 1920 ]

ACKER, JOHN N.—Age, 24 years. Enlisted, November 1, 1861, at Peekskill, to serve three years; mustered in as private, Co. I, November 19, 1861; transferred to Co. D, June 25, 1863; re-enlisted as a veteran, December 21, 1863; captured, June 22, 1864, near Petersburg, Va.; promoted corporal, no date; mustered out, May 14, 1865, at New York city; also borne as John W. Acker. [ Died around September 1879 ]

BEERS, EDWARD W.—Age, 18 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. G, April 12, 1864; captured, June 22, 1864; **died, November 9, 1864, at Andersonville, Ga.** [ NPAF ]

BLACK, JOHN.—Age, 22 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. B, August 26, 1863; transferred to Co. G, no date; captured, June 22, 1864; **died, October 6, 1864, at Andersonville, Ga.** [ No Pension Application Found/NPAF ]

BRADLEY, THEODORE.—Age, 18 years. Enlisted, December 1, 1861, at Peekskill, to serve three years; mustered in as private, Co. I, December 17, 1861; transferred to Co. D, June 25, 1863; reenlisted as a veteran, December 22, 1863; captured, June 22, 1864, near Petersburg, Va.; paroled, no date; mustered out, August 21, 1865, at New York city. [ Died 1909 ]

BURNS, HENRY.—Age, 19 years. Enlisted, August 19, 1861, at New York city, to serve three years; mustered in as private, Co. D, August 20, 1861; re-enlisted as a veteran, December 22, 1863; **wounded, June 22, 1864, near Petersburg, Va.**; **died of his wounds, July 6, 1864, at Campbell Hospital, Washington, D.C.** [ Mother applies in October 1864 ]

BURNSIDE, GEORGE.—Age, 18 years. Enlisted, September 9, 1861, at Peekskill, to serve three years; mustered in as private, Co. F, September 25, 1861; wounded in action, September 17, 1862, at Antietam, Md.; transferred to Co. D, June 25, 1863; re-enlisted as a veteran, December 22, 1863; promoted corporal, no date; captured, June 22, 1864, near Petersburg, Va. ; **died, January 3, 1865, at Salisbury, N. C.** [ NPAF ]

BURR, NELSON.—Age, 17 years. Enlisted, February 12, 1862, at Martinsburg, to serve three years; mustered in as private, Co. B, April 14, 1862; transferred to Co. C, June 25, 1863; re-enlisted as a veteran, December 22, 1863; captured, June 22, 1864, near Petersburg, Va. ; **died, August 30, 1864, at Andersonville, Ga.**; also borne as Wilson Burr. [ Parents apply for pensions on October 23, 1869 ]

BURRELL, WILLIAM.—Age, 21 years. Enlisted, January 22, 1861, at Schuyler, to serve three years; mustered in as private, Co. C, February 22, 1861; captured, June 22, 1864, near Petersburg, Va. ; **died, September 27, 1861, at Andersonville, Ga.**; also borne as Birrell. [ Mother applies on March 12, 1867 ]

BURTON, WILLIAM.—Age, 21 years, Enlisted, July 4, 1861, at Lowville, to serve three years; mustered in as private, Co. B, August 9, 1861; wounded in action, September 17, 1862, at Antietam, Md.; transferred to Co. C, June 25, 1863; captured, June 22, 1864, at Petersburg, Va. ; paroled, April 28, 1865; mustered out, September 2, 1865, at New York city. [ Died 1905 ]

CARTER, GEORGE.—Age, 30 years. Enlisted, March 20, 1864, at Croghan, to serve three years; mustered in as private, Co. B, April 1, 1864; captured" in action, June 22, 1864, before Petersburg, Va. ; paroled, no date; mustered out with company, June 30, 1865, at Munson's Hill, Va. [ Died around July 1879 ]

COLE, AMBROSE F.—Age, 36 years. Enrolled, June 20, 1861, at Lowville, to .serve three years; mustered in as first sergeant, Co. B, August 9, 1861; as second lieutenant, May 9, 1862; as first lieutenant, October 11, 1862; transferred to Co, C, June 25, 1863; mustered in as **captain**, September 16, 1863; captured, June 22, 1864, near Petersburg, Va. ; paroled, no date; mustered out, March 24, 1865; also borne as Coles. Commissioned second lieutenant, June 14 1862, with rank from May 9, 1862, vice A. Myrick promoted; first lieutenant, December 22, 1862, with rank from October 11, 1862, vice Myrick resigned; captain, August 13, 1863, with rank from July 28, 1863, vice O. Wolff; transferred to Veteran Reserve Corps. [ Died around March 1876 ]

CUSH, BARNARD.—Age, 24 years. Enlisted, January 7, 1861, at Lowville, to serve three years; mustered in as private, Co. C, February 19, 1864; captured, June 22, 1864, near Petersburg, Va. ; paroled, April 21, 1865; mustered out, June 21, 1865, at New York city. [ Applies as an invalid on June 20, 1876 ]

CUTLER, WILLIAM.—Age, 18 years. Enlisted, August 23, 1861, at Kingston, to serve three years; mustered in as private, Co. E, August 26, 1861; wounded, no date; transferred to Co. B, June 25, 1863; re-enlisted as a veteran, December 22, 1863; captured, June 22, 1864; **died of disease, August 6, 1864, at Andersonville, Ga.**; also borne as Culter and Cutler. [ NPAF ]

DAY, JOSEPH W.—Age, 21 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. E, May 23, 1864; captured, June 22, 1864; **absent, at Camp Parole, Annapolis, Md., at muster-out of company.** [ NPAF ]

DEVINE, JAMES.—Age, 23 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. A , February 29, 1864; promoted corporal, no date; captured, June 22, 1864, near Petersburg, Va. ; **absent, a prisoner of war, at muster out of company**; veteran. [ NPAF ]

DIXON, GEORGE.—Age, 28 years. Enlisted at Stevensburg, Va., to serve three years, and mustered in as sergeant, Co. K, March 17, 1864; captured, June 22, 1864, at Petersburg, Va. ; paroled, April 30, 1865; mustered out with company, June 30, 1865, at Munson's Hill , Va. ; veteran. [ Died December 22, 1879 at Alamosa, CA ]

DOW, WILLIAM.—Age, 22 years. Enlisted at Lowville, to serve three years, and mustered in as private, Co. C, February 9, 1864; captured, June 22, 1864, near Petersburg, Va. ; **sent to Lynchburg, Va., June 29, 1864; no further record.** [ NPAF ] There was a major Confederate hospital at Lynchburg; Dow was **probably wounded.** ]

FOSTER, JUSTIN N.—Age, 24 years. Enlisted, October 1, 1861, at Peekskill, to serve three years; mustered in as private, Co. F, October 12, 1861; promoted sergeant, October 12, 1861; first sergeant, January 26, 1863; reduced to sergeant in March or April, 1863; transferred to Co. D, June 25, 1863; re-enlisted as a veteran, December 22, 1863; promoted first sergeant, June 20, 1864; captured in action, June 22, 1864, near Petersburg, Va. ; paroled, April 21, 1865; mustered out, May 14, 1865, at New York city; also borne as Justus N. , and Justin H. Foster. [ NPAF ]

FOWLER, WILLIAM.—Age, 25 years. Enlisted at Tarrytown, to serve three years, and mustered in as private, Co. D, January 26, 1864; captured, June 22, 1864, near Petersburg, Va. ;

paroled, no date; died of disease, December 11, 1864, at Annapolis, Md. [ Mother applies December 8, 1865 ]

FUNDY, FITCH.—Age, — years Enlisted, January 1, 1864, at Brookfield, to serve three years; mustered in as private, Co. B , January 21,1864; captured in action, June 22,1861, near Petersburg, Va . ; died, October 4, 1864, at Andersonville, Ga. [ NPAF ]

GARDINER, BENJAMIN F.—Age, 23 years. Enlisted, October 20,1861, at Peekskill, to serve, three years; mustered in as private, Co. I, December 10, 1861; transferred to Co.. D, June 25, 1863; re-enlisted as a veteran, December 22, 1863; captured in action, June 22, 1864, at Petersburg, Va., paroled, no date; absent, at Camp Parole, Annapolis, Md., at muster-out of company; also borne as Gardemire, Gardinier, Gardner and Gordinier.[ Widow/minor applications made on May 1, 1865 ]

GOODMAN, PETER.—Age, 18 years. Enlisted at Scarsdale, to serve three years, and mustered in as private, Co. G, September 12, 1861; transferred to Co. B, November 1, 1861; to Co. C, June 25, 1863; re-enlisted as a veteran, December 22, 1863; wounded in action, May 7, 1864, at the Wilderness, Va . ; captured, June 22, 1864; paroled, no date; absent, at City Point Hospital, at muster-out of company. [ NPAF ]

HAMBLIN, GEORGE.—Age, 18 years. Enlisted, March 23,1864, at High Market, to serve three years; mustered in as private, Co. B, April 6, 1864; captured, June 22, 1864, before Petersburg, Va. ; paroled, no date; mustered out, June 23, 1865, at Albany, N .Y . [ Died 1911 ]

HAMILTON, HENRY N.—Age, 21 years. Enrolled, September 1, 1861, at Bellville, Ohio, to serve three years; mustered in as private, Co. H , October 3, 1861; promoted sergeant, no date; mustered in as second lieutenant, Co. E, October 6, 1862; transferred to Co. B, June 23, 1863; mustered in as **first lieutenant**, Co. E, October 26, 1863; captured in action, June 22, 1864, in front of Petersburg, Va. ; paroled, no date; discharged, April 28, 1865; also borne as Henry U. and Henry W. Commissioned second lieutenant, November 17, 1862, with rank from October 6, 1862, vice H . V . Tompkins promoted; first lieutenant, February 13, 1864, with rank from October 26, 1862, vice W i l l i a m McFadden promoted. [ Died October 30, 1917 at Belleville, OH ]

HANLEY, JAMES.—Age, 18 years. Enlisted, March 23, 1864, at High Market, to serve three years; mustered in as private, Co. C, April 1, 1864; captured, June 22, .1864, at Petersburg, Va . ; no further record; also borne as Huntley, Hundley and Handly.[ NPAF ]

HANLEY, WILLIAM.—Age, 40 years. Enlisted at Washington, to serve three years, and mustered in as private, Co. F, November 28, 1861; wounded in action, September 17, 1862, at Antietam, Md.; transferred to Co. D, June 25, 1863; captured, June 22, 1864, near Petersburg, Va. ; died, January 14, 1865, at Andersonville, Ga. [ Widow applies December 16, 1865 ]

HARRIS, GEORGE H.—Age, 19 years. Enlisted, July 26, 1861, at New York city, to serve three years; mustered in as private, Co. A, August 16, 1861; promoted corporal, April 25, 1864; returned to ranks, June 18, 1861; captured, June 22, 1861, in front of Petersburg, Va. ; paroled, no date; mustered out, January 25, 1865, at New York city. [ Died 1905 ]

HART, JOSEPH.—Age, 23 years. Enlisted, August 27, 1861, at Adams, to serve three years; mustered in as private, Co. G, August 31, 1861; transferred to Co. B, November 1, 1861; to Co. C, June 25, 1863; re-enlisted as a veteran, December 22, 1863; wounded in action, June 22, 1864, near Petersburg, Va. ; died of his wounds, July 6, 1864, at Lincoln Hospital, Washington, D.C. [ Widow applies July 27, 1864 ]

HOPKINS, DAVID.—Age, 18 years. Enlisted, September 30, 1861, at Putnam County, to serve three years; mustered in as private, Co. I, October 4, 1861; transferred to Co. D, June 25, 1863; captured, June 22, 1864, near Petersburg, Va. ; paroled\*, no date; mustered out, July 5, 1865, at New York city. [ Died around May 1900 ]

HOPKINS, JOSEPH.—Age, 18 years. Enlisted, October 3, 1861, at Putnam County, to serve three years; mustered in as private, Co. I, October 12, 1861; promoted corporal, April 1, 1863; transferred to Co. D, June 25, 1863; captured, June 22, 1864, near Petersburg, Va. ; paroled, no date; mustered out, October 30, 1865, at Rochester, N. Y. , as Joseph H. Hopkins. [ Died March 1, 1916 at Lake Mahopac, NY ]

HORTON, JAMES.—Age, 24 years. Enlisted, March 4, 1864, at Cairo, to serve three years; mustered in as private, Co. C, March 8, 1864; captured, June 22, 1864, at Petersburg, Va. ; absent, prisoner of war, at muster-out of company. [ Father applies for pension on August 30, 1879 ]

JOHNSON, THOMAS.—Age, 18 years. Enlisted, August 23, 1861, at Kingston, to serve three years; mustered in as private, Co. E, August 26, 1861; transferred to Co. B, June 25, 1863; captured in action, June 22, 1864, at Petersburg, Va. ; paroled, April 21, 1865; mustered out, June 21, 1865, at New York city. [ Died January 30, 1921 at White Plains, NY ]

KELLY, JOHN.—Age, 36 years. Enlisted, June 15, 1861, at Lowville, to serve three years; mustered in as private, Co. B, August 9, 1861; promoted corporal, January 21, 1863; transferred to Co. C, June 25, 1863; re-enlisted as a veteran, December 22, 1863; captured in action, June 22, 1861, at Petersburg, Va. ; paroled, April 21, 1865; mustered out, June 28, 1865, at New York city; also borne as Kelley. [ NPAF ]

KELLY, WILLIAM.—Age, 22 years. Enrolled, July 20, 1861, at New York city, to serve three years; mustered in as private, Co. A , August 2, 1861; promoted sergeant in October, 1861; first sergeant, September 17, 1862; regimental commissary sergeant, January 11, 1863; mustered in as second lieutenant, Co. C, April 19, 1864; as **first lieutenant**, Co. D, June 20, 1864; **wounded in action, June 22, 1864, near Petersburg, Va. ; discharged for disability, October 22, 1864, at Kelley.** Commissioned second lieutenant, February 13, 1864, with rank from June 24, 1863, vice E. M. Wright, resigned; first lieutenant, June 10, 1864, with rank from April 27, 1864, vice A. Hubbell promoted. [ Applies as invalid in May 1865 ]

LEVERICH, CHARLES W.—Age, 18 years. Enlisted, February 2, 1864, at Tarrytown, to serve three years; mustered in as private, Co. D, February 26, 1864; captured, June 22, 1864, near Petersburg, Va . ; paroled, no date; mustered out with company, June 30, 1865, at Munson's Hill, Va . ; also borne as Laverich. [ Died July 17, 1916 at Yorktown Heights, NY ]

LOGEMAN, WILLIAM.—Age, 35 years. Enrolled, August 11, 1861, at New York city, to serve three years; mustered in as sergeant, Co. D, August 20, 1861; promoted first sergeant, August 28, 1862; deserted, March 26, 1863; rejoined company in November or December, 1863, as private; captured, June 22, 1864, near Petersburg, Va . ; paroled, November 20, 1864; mustered out, January 7, 1865, at New York city; also borne as Lagemann. Commissioned, not mustered, second lieutenant, March 23, 1863, with rank from December 13, 1862, vice H . Seymour died of wounds. [ NPAF ]

MARTIN, JAMES.—Age, 24 years. Enlisted, September 29, 1861, at Carmel, to serve three years; mustered in as private, Co. I, October 9, 1861; transferred to Co. D, June 25, 1863; captured, June 22, 1864, near Petersburg, Va . ; paroled, April 21, 1865; mustered out, July 5, 1865, at New York city. [ Died May 4, 1914 at Norton Heights, CT ]

McCLERENCE, WILLIAM.—Age, 32 years. Enlisted, July 24 1861, at New York city, to serve three years; mustered in as private, Co. A , August 2, 1861; promoted corporal, September 1, 1862; re-enlisted as a veteran, December 22, 1863; promoted sergeant, March 31, 1864; **wounded in action, June 22, 1864**, near Petersburg, Va . ; mustered out, September 17, 1864, near Petersburg, Va.; also borne as McLerence. [ Died January 11, 1914 at Providence, RI ]

McCREA, JAMES.—Age, 24 years. Enlisted at Stevensburg, Va., to serve three years, and mustered in as sergeant, Co. K , March 17, 1864; captured in action, June 22, 1864, at Petersburg, Va . ; paroled, no date; mustered out with company, June 30, 1865, at Munson's Hill, Va . ; veteran. [ Died September 3, 1906 ]

McFADDEN, WILLIAM.—Age, 32 years. Enrolled, September 15, 1861, at Bellville, Ohio, to serve three years; mustered in **as** private, Co. I, September 21, 1861; as second lieutenant, Co. H, October 21, 1861; **as** first lieutenant, April 16, 1862; as **captain**, October 26, 1862; transferred to Co. B, June 25, 1863; captured in action, June 22, 1864, in front of Petersburg, Va . ; escaped from prison, no date; mustered in as major,. September 16, 1864; discharged, January 12, 1865. Commissioned second lieutenant, December 24, 1861, with rank from October 30, 1861, original; first lieutenant, May 13, 1862, with rank from April 16, 1862, vice W. Lyne promoted; captain, December 22, 1862, with rank from October 26, 1862, vice G. J . Jennings died of wounds; major, September 16, .1864, with rank from June 30, 1864, original. [ Appears to have died around 1880 ]

MELSHLER, FREDERICK.—Age, 34 years. Enlisted at Tarrytown, to serve three years, and mustered in as private, Co. C, February 19, 1864; captured in action, June 22, 1864, near Petersburg, Va . ; **no further record**; also borne as Milcher and Melcher.[ **Widow applies June 5, 1869** ]

MOHR, JOHN.—Age, 22 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. D, September 12, 1861; transferred to Co. C, November 1, 1861; promoted corporal in January, 1863; re-enlisted as a veteran, December 22, 1863; promoted sergeant, March 1, 1864; captured in action, June 22, 1864, near Petersburg, Va . ; mustered out, June 24, 1865, at New York city; also borne as Maher. [ NPAF ]

MORRIS, MICHAEL.—Age, 22 years. Enlisted, August 5, 1861, at New York city, to serve three years; mustered in as corporal, Co. B, August 9, 1861; transferred to Co. C, June 25, 1863; re-enlisted as a veteran, December 22, 1863; captured in action, June 22, 1864, near Petersburg, Va . ; paroled, April 21, 1865; mustered out, June 17, 1865, at New York city. [ died August 29, 1917 at Burlington, TX ]

B, April 1, 1864; captured in action, June 22, 1864, before Petersburg, Va. ; **died, October 14, 1864, at Andersonville, Ga.**; also borne as Mullin. [ Widow/minor applications in July 1865 ]

MURTHUR, DENNIS.—Age, 25 years. Enlisted, August 23, 1861, at Kingston, to serve three years; mustered in as private, Co. E, August 24, 1861; transferred to Co. B, June 25, 1863; re-enlisted as a veteran, December 22, 1863; captured in action, June 22, 1864, before Petersburg, Va. ; confined at Andersonville, Ga., and paroled, no dates; mustered out, June 22, 1865, at New York city, as Murtha. [ NPAF ]

NUGENT, ANDREW.—Age, 23 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. C, February 16, 1864; captured in action, June 22, 1864, at Petersburg, Va. ; paroled, April 21, 1865; mustered out, June 20, 1865, at New York city; also borne as Nugant.[ Died May 15, 1921 at Constableville, NY ]

OMESBY, ALVIN.—Age, 27 years. Enlisted at Tarrytown, to serve three years, and mustered in as private, Co. D, February 27, 1864; captured, June 22, 1864, near Petersburg, Va. ; paroled, no date; **absent at Camp Parole, Annapolis, Md., at muster-out of company**; also borne as Oliver Ormsby and Ormsbie. [ NPAF ]

O'NEIL, PATRICK.—Age, 24 years. Enlisted at PosfSacket, to serve three years, and mustered in as private, Co. I, October 24, 1861; promoted corporal, no date; transferred to Co. D, June 25, 1863; captured in action, June 22, 1864, near Petersburg, Va. ; paroled, no date; **died of disease, December 17, 1864, at Camp Parole, Annapolis, Md.** [ Widow applies August 20, 1866 ]

PEELER, GEORGE.—Age, 23 years. Enlisted, February 26, 1864, at Albany, to serve three years; mustered' in as private, Co. C, March 8, 1864; captured in action, June 22, 1864, at Petersburg, Va. ; **died, November 15, 1864, in Blackshear Prison, Ga.** [ Father applies unsuccessfully in 1879]

PILKINTON, JOHN.—Age, 29 years. Enlisted at Tarrytown, to serve three years, and mustered in as private, Co. C, February 27, 1864; captured, June 22, 1861, near Petersburg, Va.; returned to regiment, June 22, 1865; mustered out with company, June 30, 1865, at Munson's Hill, Va., as Pilkington. [ NPAF ]

RATHBURN, WILLIAM.—Age, 23 years. Enlisted at Lowville, to serve three years, and mustered in as private, Co. O, August 31, 1861; transferred to Co. B, November 1, 1861; to Co. C, June 25, 1863; re-enlisted as a veteran, December 22, 1863; captured,

June 22, 1864, near Petersburg, Va. ; **died, October 28, 1864, in hospital, at Andersonville, Ga.**; also borne as William' R. and Rathbun.[ Mother applies June 8, 1880 ]

REBMAN, JOSEPH.—Age, 32 years. Enlisted, August 10, 1861, at New York city, to serve three years; mustered in as private, Co. C, August 20, 1861; promoted corporal, November 1, 1861; sergeant, July 1, 1862; first sergeant, November 24, 1862; returned to ranks, no date; captured, June 22, 1864, near Petersburg, Va. ; **died, January 15, 1865, at Andersonville, Ga.**; also borne as Repman and Bebman.[ Widow applies June 14, 1865 ]

RENFREE, HENRY.—Age, 24 years. Enlisted, August 6, 1861, at New York city, to serve three years; mustered in as private, Co. B, August 9, 1861; transferred to Co. C, June 25, 1863; re-enlisted as a veteran, December 22, 1863; captured, June 22, 1864, near Petersburg, Va. ; mustered out, June 28, 1865, at New York city; also borne as Remfree. [ NPAF ]

C, June 25, 1863; re-enlisted as a veteran, December 22, 1863; promoted corporal in December, 1863; captured in action, June 22, 1864, at Petersburg, Va. ; **absent, prisoner of war at muster-out of company**; also borne as Scanlan. [ NPAF ]

SCHRIVER, LUDWIG.—Age, 47 years. Enlisted, February 19, 1864, at Tarrytown, to serve three years; mustered in as private, Co. C, February 29, 1864; captured in action, June 22, 1864, near Petersburg, Va. ; **died, October 22, 1864, at Andersonville, Ga.**; also borne as Scriber and Ludenwick Schwin. [ NPAF ]

SELSAM, HENRY.—Age, 44 years. Enlisted at New York city, to serve three years, and mustered in as private, Co. C, October 30, 1861; captured, June 22, 1864, near Petersburg, Va. ; **died, November 5, 1864, at Andersonville, Ga.**, as Seismann. [ Widow applies January 27, 1865 ]

SHERMAN, REUBEN.—Age, 21 years. Enlisted, September 20, 1861, at Fulton, to serve three years; mustered in as corporal, Co. E, September 23, 1861; transferred to Co. B, June 26, 1863; re-enlisted as a veteran, December 22, 1863; promoted sergeant, April 10, 1864; captured in action, June 22, 1864, at Petersburg, Va. ; returned to ranks, no date; promoted sergeant, February 25, 1865; paroled, April 28, 1865, at Andersonville, Ga.; mustered out, June 14, 1865, at New York city. 9-10 men are listed as absent in hospitals or as “no further record” after capture. For the most parts, their fates are inconclusive since few of them or their survivors seems to have made pension applications. Cemetery records are getting better at Annapolis National Cemetery but them are far from complete.

Based on the above, the best that can be determined is that from 37% to 53% died in Southern prisons or shortly after release from one.

6 men mustered out at Munson’s Hill, VA on June 30, 1865. None of the Union soldiers in this group seems to have returned to duty while the war was ongoing.
