53 names: 3 officers and 50 enlisted men, of whom 16 died in (or of) imprisonment, primarily at Salisbury, NC.

Official Records and Phisterer counts the missing as 3 officers and 50 enlisted men.

The Official Records states that they "…were captured entire…" [OR1, Vol. XLII, part 1, pp.534-536: General Edward S. Bragg report of September 5, 1864] Depositions state that the soldiers were put into Libby Prison in Richmond for a few days and then moved to Belle Island for around six weeks and then moved to Salisbury. This study remains inconclusive for now. There are some assumptions in these numbers, such as those who were mustered out at hospitals in early to mid-1865. *Not all who <u>were</u> captured are mentioned in the NYSAG rosters as <u>being</u> captured. The most prominent example her is that of Alonzo Moon. I will be the first to admit that there is more "educated guesswork " here than I would like (but the numbers come out pretty well).* 

In other studies like this where the names/numbers are more reliable and backed by a newspaper list, for example, Weldon RR. and Reams Station captives died at around 50%, give or take a few points. I am counting, as well, those who died in transit to release points or at Union hospitals at Annapolis or Wilmington, and many more, as well as those who died as paroled prisoners on furlough at their homes in the North, if there is some evidence they died of complications from captivity. Some might cry "fowl" but the fact remains that if you were injured at Main and Broad and stumbled to Main and Second where you died, the cause of your death started at Main and Broad. That's how I see it.

Strictly counting, 11 of the 16 dead here died <u>at Salisbury prison</u>. Counting as above, however, makes the numbers 32% who died overall. Salisbury only equals 22% dead.

The last figures I saw for Salisbury overall was 28% in a sidebar article in *America's Civil War* magazine, June 2014. I have watched the numbers creep ever upwards over ten years now.
